#### **QUESTIONS & ANSWERS**

The following are questions and answers pertaining to the MSHSAA Constitution and By-Laws and/or MSHSAA Board of Directors policy. These are provided as an aid in interpreting the rules and regulations which MSHSAA member schools have adopted. If you have a specific area and/or question which you would like explained, contact Dr. Kerwin Urhahn, MSHSAA executivetor. Your attention is called to the fact questions and answers regarding interpretations of the MSHSAA Constitution and By-Laws appear following the Constitution Article or By-Law they relate to in the MSHSAA Official Handbook.

**Question:** Our school has applied and been approved to participate in a cooperative sponsorship in baseball. Our school board now wants to void the sponsorship and enter into a cooperative sponsorship with another school in baseball. May our school do this?

**Answer:** No. By-Law 1.4.1 provides that two schools may mutually dissolve a cooperative sponsorship but such decision may not occur unilaterally. Further, if a school ends a cooperative sponsorship it may not enter into another cooperative sponsorship in that sport until the next two-year cycle. Therefore, your school cannot enter into an agreement with another school. (By-Law 1.4.1)

**Question:** School A, a Class 1 school, is bordered by a Class 5 school, a Class 2 school and a K-8 district. School A wants to co-op with the Class 1 school on the other side of the K-8 district which is not contiguous to School A due to the K-8 district. May this occur since there is a Class 2 district which is contiguous to School A?

**Answer:** Yes, provided cooperatively sponsoring the program(s) with the contiguous class 2 school is not an option as all co-ops must be with mutual approval of both school districts. Your school or the class 2 school is not required to try to co-op with each other. (By-Law 1.4.1)

**Question:** A small Class 1, Grades 7-12 member school, has a junior high basketball season with a team comprised of grades 7-9. Following the junior high season, the school wants to have a cooperative sponsorship agreement with a neighboring member school in girls basketball to include the ninth graders moving up to the cooperative sponsorship high school team after the junior high season is over. Would this be allowed under By-Law 1.4.1?

**Answer:** Yes, provided the ninth graders do not exceed the 20-week participation limit, quarter and tournament limitations. (By-Law 1.4.1)

**Question:** One of our swimmers has approached our principal requesting to miss this upcoming Friday school swimming practice to travel to Oklahoma for a non-school swimming meet on Saturday. Our team has practice on Friday and does not compete until Tuesday. Would it be acceptable for our principal and coach to approve this request?

**Answer:** Yes. This is not a replacement of school practice and is considered as a case by case request as permitted in the by-law (3.13.2.a) to be addressed by the local school administration. This decision rests with the school.

**Question:** In the posting of our open facility our softball coach stated "Any girl wanting to play softball may come to the open facility." Is this a proper posting?

**Answer:** No. The "wanting to play softball" implies future team membership. It is acceptable to say "Open facility for softball play".

From the Greatest Generation to Baby Boomers, Generation X to Millennials, teenagers in every era have had challenges growing up.

In today's digital world, high school students are being tested in unique and demanding ways. The Washington Post confirms that 73 percent of all American teenagers own their own smartphone and, on average, spend almost nine hours a day texting, chatting, gaming, blogging, streaming and visiting with friends online.

Although conclusive research showing a direct correlation between the mental health of teenagers and smartphone usage won't be complete for years, it isn't a great confidence builder for a student to discover online that everyone else seems to have more friends.

In addition, recent figures indicate that more than 31 percent of America's 42 million teenagers are overweight or obese, compared to only five percent in 1980. According to the 2016 National Survey of Children's Health, Missouri is ranked the 32nd most obese state in the nation with 29.4 percent of all teenagers considered overweight.

#### **Growing Up in the Digital Age**

Not surprisingly, many psychologists and researchers agree that today's teenagers are more lonely, anxious and depressed than ever before.

As the new school year gets underway and social pressures increase, statistics like these verify how important it is for teenagers to participate in high school sports and other activities such as marching band, choir, speech and debate.

The most recent survey by the National Federation of State High School Associations (NFHS) indicates there are almost eight million participants in high school sports and more than four million in performing arts activities. Most of these students would agree the primary advantage of playing a sport or participating in an after-school activity is the opportunity to meet new people and develop meaningful friendships. An online chat is no substitute for working toward a common goal face-to-face, side-by-side for weeks on end with teammates.

And positive social relationships are only the beginning. Among other benefits, high school sports are instrumental in helping teenagers establish nutritional and exercise habits that will carry them for a lifetime. Participating in a sport in high school is a great way to maintain a healthy weight, establish good eating and sleeping habits, discourage the use of alcohol and drugs and develop a greater sense of self-esteem.

Additional benefits of participating in a high school sport or activity are shared by the NFHS on a new website at MyReasonWhy.com, where dozens of high school students address this topic in their own words through videos.

A new school year brings with it an opportunity for teenagers to make new friends and establish new lifestyle habits. Encouraging them to make friends on the field of play as well as online is great way to start.

#### **2019 Board of Directors Elections: Southeast and Southwest Districts**

The annual MSHSAA Board of Directors election will be conducted in April in accord with provisions contained in Article IV, Sections 3 and 4 of the MSHSAA Constitution. Member schools from the Southeast and Southwest districts as well as Region 1 At-Large (Kansas City and St. Louis Districts) will elect Board members for four-year terms.

Primary (nomination) ballots will be e-mailed to member schools in the three districts on February 11 and must be received in the MSHSAA office no later than March 4. The names of the three persons receiving the highest number of votes in the primary election in each district will appear on the final ballot unless there is a tie for the third highest position. In such cases, only the names of the persons receiving the two highest number of votes will be placed on the final ballot.

Final ballots will be on-line for all schools in the four districts on April 1 and must be submitted through the MSHSAA website no later than May 1. All ballots are sent to the attention of the school principal.

#### **Annual Election to Amend MSHSAA Constitution and By-Laws**

The 2019 MSHSAA annual election to amend the Constitution and By-Laws will again be held in April. The proposed amendments and background information will be distributed to member schools the last week in March. The Annual Ballot will be on-line the first week in April. All ballots are required to be finalized on-line by the school principal no later than May 1.

#### 2019 Investigative Committee Elections

The investigative committee from each of the eight MSHSAA board districts shall consist of one public school administrator, one nonpublic school administrator, and one at-large school representative.

Each year, one of the members will rotate off the committee and a replacement shall be voted on by the membership. Only self-nominations for the appropriate category for replacement members can be accepted (public member will need to be replaced by a public school nominee, nonpublic member will need to be replaced by a nonpublic school nominee, and an at-large member can be a nominee from either public or nonpublic schools). Each district's nomination ballot will list the specified membership category to be voted on for the respective district for the current year.

The self-nomination ballots will be e-mailed to the member school principals on February 11 and must be received in the MSHSAA office no later than March 4. The ballot listing the nominees received will be on the MSHSAA website for member schools' principals on April 5, with a due date of May 1. Please be certain to participate in these elections.

#### **Coaches and Activities Directors** Influence MSHSAA Program

The MSHSAA has advisory committees, appointed by the Board of Directors, for each sport and activity in which district and state events are sponsored. Each committee makes recommendations to the Board regarding matters relating to the sport or activity concerned. Some of these are in the form of regulations for the administration of district and state events which become effective when approved by the Board of Directors. Others involve proposals to amend the Constitution and By-Laws which must be put to a vote of the schools when accepted by the Board. The record shows that approximately 80-percent of the recommendations of these committees are approved by the Board and have resulted in significant changes in the MSHSAA program.


This is the Board of Director's procedure for allowing coaches and those involved at the grass roots level to make contributions. The only concern of the Board is that the recommended changes are acceptable to school administrators and do not adversely affect other activities.

The names of advisory committee members are contained in the manuals published for the sport or activity concerned. Coaches, music directors, and speech directors who desire to have changes considered should contact the person on the particular advisory committee from his or her district. Some advisory committee members hold meetings in their areas at the time of district events to get a consensus from their colleagues. This procedure is encouraged to involve as many persons as possible.

Frequently, suggestions from advisory committees are first placed on the Annual MSHSAA Questionnaire sent to member schools in February each year to get a consensus from the schools to determine whether a proposal is satisfactory. In addition to providing the Board of Directors with information regarding the position of school administrators on the matter, it provides an opportunity for each school to give consideration to proposed changes. School administrators are urged to meet with members of their staffs concerned. This course helps provide programs that are acceptable to the majority of persons who are interested in the educational welfare of our youth.

#### **MSHSAA Board of Directors Policy Regarding Specialized Sport Camp Fees**

Provisions contained in MSHSAA By-Laws 3.13.6.b and 3.15.5.e stipulate that fees (tuition) for summer athletic camps shall be provided by the student or the student's parents precludes a school from being involved in any group projects to raise money to pay these fees. This restriction applies to a booster club as well as to school coaches. As far as the restriction on athletes is concerned, it would be permissible for several members of a school team to assemble themselves for the purpose of collectively undertaking work projects such as a car wash, a bake sale or other similar type of activities to earn money which could be applied toward camp fees. Under such circumstances all money earned shall go directly to the student to be used at his or her discretion. If the students assemble themselves collectively there can be no requirement that the money

#### Soccer Advisory Committee Summary

#### Held December 3, 2018, at MSHSAA Office, Columbia

Recommend to accept the Open Facilities/Contact Facilities proposal as follows:

Eliminate the current open facilities procedure and implement a maximum three hours per week for off-season voluntary contact hours. The contact time can be sport and gender specific. Any contact time, on a given day, will count toward the three allowable hours and the contact time, on a specific day, cannot exceed 90 minutes. - Recommend to accept the proposal for a Class 1-4 State Championship Weekend for the boys in the fall and the girls in the spring with semifinals on Friday and finals/third place games on Saturday.
- Recommend to implement the Class 1-4 State Championship Weekend format for boys immediately (2019-20) and for the girls to begin when the new contract starts at the World Wide Technology Soccer Park in Fenton beginning in 2020-2021.

- Recommend a point of emphasis for officials to include enforcing persistent fouling and applying penalties as necessary.
- Recommend a point of emphasis for referees to properly use assistant referees more in game management.
- Recommend that all third place games at the state tournament be played out with OT and PKs.
- Recommend lowering the goal differential in the mercy rule from 10 goals to 8 goals.
- Recommend that wording in the soccer manual regarding regular season tournament play (Section 1, E. Duration of Game/Overtime Procedures) be adjusted as follows:
- 2. Regular season tournament play where no advancement from an established bracket is necessary overtime is optional. The options are as follows: (1) no overtime, or (2) the overtime procedure shall be two ten-minute sudden victory periods with the National Federation Penalty Kick Procedure to follow if necessary. The winning team after overtime, and penalty kicks if necessary, will record this result as a win and the losing team will record this result as a loss on their seasonal records. Overtime procedures will be determined at the discretion of the tournament host and must be provided in advance to all tournament participants.

Time modifications have been made in the schedule for the weekends to reflect a recommendation of the MSHSAA Basketball Advisory Committee and approved by the Board of Directors. Admission prices have been set at \$9 per session.

#### **Board Interpretation on** "Halftime Shootouts"

Following is an interpretation of the MSHSAA Amateur Awards Standards (By-Law 3.6) as they apply to athletic skill contests. The interpretation was adopted by the Board of Directors at its July 1, 1985 meeting.

"When a student is selected by chance to participate in a carnival type contest involving a skill of a sport, he or she may receive cash or merchandise awards as a result of that participation without its affecting his or her eligibility under the MSHSAA Amateur and Awards Standards. An example of this would be where a student is selected to participate in a half-time promotion at a University basketball game on the basis of a chance drawing of a number on a program which he or she purchased at the game.

In cases where such activities are scheduled and a student is required to enter for the purpose of competing for a cash or merchandise award, such activity would come under the restrictions of the amateur and awards standard and a youngster would jeopardize his or her eligibility in the sport concerned by competing for or accepting such awards."

#### State Music Festival Scheduling

Problems scheduling performances at the MSHSAA State Music Festival due to local conflicts (i.e. proms, musicals, theatrical productions, athletic events, etc.) are becoming more prevalent. Due to the size of the festival, it is impossible to schedule every performance to avoid local conflicts.

School administrators and activities directors are asked to avoid scheduling local events that will conflict with the MSHSAA Music Festival performances. The dates of the 2019 Festival are scheduled for April 25-27.

Music directors should also be aware that with approximately 9,000-10,000 students participating at the State Festival each year, some events from your school may be scheduled at the same time. It is impossible to build a schedule that will allow every director to hear each entry. Therefore, schedule changes will only be made if there is a direct conflict with an accompanist or a student scheduled for two events during the same time period. Please remember that an individual may accompany no more than 20 entries per day at the district and state music festivals.

Due to the number of participants at the State Festival, the MSHSAA staff will not be able to honor specific performance time requests. In an effort to assist school administrators and music directors in making appropriate plans for the event as far in advance as possible, a brief summary of the scheduling process is being presented.

Schools should plan to have their schedule encompass the amount of time indicated below. These performance schedules are based on the average amount of time necessary to accommodate the entries as listed.

40 or more entries	allow 8 hours
30-39 entries	allow 7 hours
20-29 entries	allow 6 hours
10-19 entries	allow 5 hours
6-9 entries	allow 4 hours
5 or fewer entries	allow 3 hours

Schools spending the night prior to their performance date should plan on beginning early in the morning. Schools spending the night the day of the performance should plan on performing through the end of the day. Schools with many entries will be scheduled to occupy

the mid-morning through afternoon time slots.

When listing accompanists, it is very important that only a true accompanist is listed. If directors list themselves and are not truly accompanying the performance, scheduling problems for their school and other schools may occur. Please list events appropriately. Your cooperation is appreciated.

As a reminder please review the MSHSAA State Solo and Small Ensemble Festival Assignment by Day link located on the music activities page of the MSHSAA website. The three day MSHSAA State Music Festival schools are divided equally across the three days. This year, schools assigned to Group C will perform on Thursday, April 25, Group A will perform on Friday, April 26 and Group B will perform on Saturday, April 27. If you are unsure which day you are assigned, go to the Music Activities link of the MSHSAA web site (www.mshsaa.org). If your school is not listed, the school did not register for post-season music for the 2018-19 school year, and you should contact MSHSAA immediately.

#### **Parental Permission Statement Reminder for Spring Sports**

MSHSAA By-Law 3.7 requires each student participating in interscholastic athletic competition to furnish a statement, signed by the student's parents or guardians, which grants permission for the student to participate in interscholastic athletics. As an aid to member schools in complying with this requirement, the MSHSAA includes a recommended parental permission statement on the MSHSAA physical examination form, available on the MSHSAA Web Site.

Included as a part of the recommended parental permission statement is a statement acknowledging that the parents consent for the student to accompany the team on trips. It further acknowledges that in case of a medical emergency where the parents cannot be reached, the school official with supervisory responsibility for the individual student or group of students on the trip is authorized to obtain emergency medical assistance through a physician or hospital of the supervisors choice which would be considered reasonably necessary for the welfare of the student.

While the parental permission form is required of all athletes, MSHSAA By-Laws do not require them for students participating in nonathletic activities or for students who serve in a support capacity for an athletic team such as statistician, manager, etc. However, the MSHSAA has been advised of a medical emergency that arose involving a student who was accompanying an athletic team to videotape games. Unfortunately, the school in question did not have a parental consent form signed for the student which authorized the school supervisor to obtain emergency medical care. Luckily, the school was able to contact the parents and obtain this permission by telephone after a significant delay.

Because of this experience, it is strongly recommended that school administrators require that signed parental permission statements be on file for all students who travel as a part of an official school party to participate in any type of interschool activity. This will authorize school representatives to seek medical help in emergency situations. These signed statements should accompany the school supervisor on every school trip. It may be of further assistance to have these forms notarized.

Garner presented the Board with three recommendations from the Athletic Directors Advisory Committee: 1) Eliminate the current open facilities procedure and implement a maximum three hours per week for off season voluntary contact hours. The contact time can be sport and gender specific. Any contact time, on a given day, will count toward the three allowable hours and the contact time, on a specific day, cannot exceed 90 minutes. The opportunity to participate is open to enrolled students. Player skill development will be permitted. No team offense or team defense concepts will be covered. Contact hours will be as followed:

- Fall: Begins on Tuesday of Week #10 and ends on the Friday of Week #16
- Winter: Begins on Monday of Week #22 and ends on the Friday of Week #33

No contact is allowed during Weeks #26, #27, #28

- Spring: Begins on Monday of Week #39 and ends 1 week prior to the school's last day of classes; 2) in the sports of cross country and golf: when only two schools are entered in the team competition of the district tournament. only one team and five additional individual competitors will advance to the next level of competition; 3) to allow three member schools to form a cooperative agreement.

Referred all three recommendations of the Athletic Directors Advisory Committee to the Area Meetings as topics of discussion.

Maurer presented the Board with two recommendations from the Cross Country Advisory Committee: 1) that middle school cross country races be two miles in distance; 2) that all district and sectional cross country meets be required to have a camera at the finish line as a backup for determining places.

Approved both recommendations of the Cross Country Advisory Committee.

Urhahn shared the minutes of the Public/Nonpublic Advisory Committee with the Board. The committee had no recommendations for the Board. Urhahn reported that the committee was not entirely supportive of the link rule. No action taken.

Mazzocco presented the Board with one recommendation from the Baseball Advisory Committee: The committee recommended to place on the Annual Ballot a question to change the contest limitations for both the Fall and Spring by removing the 14 games and 3 tournaments option and replace it with a 16 games and 3 tournament option.

Approved the recommendation of the Baseball Advisory Committee as an Annual Ballot question.

Mazzocco reported to the Board from the Softball Advisory Committee with three committee recommendations: 1) surveying member schools to expand Fall District window to go from Tuesday to Saturday; 2) to place on the annual ballot a question to change the contest limitations for both the Fall and Spring by removing the 14 games and 3 tournaments option and replace it with a 16 games and 3 tournament option; 3) to develop language for the Softball Manual to clarify permissible and impermissible bench/dugout conduct during the regular season. The committee also went on record in support of the "off-season practice" plan proposed by the Athletic Directors Advisory Committee.

Approved recommendations #1 and #3, approve recommendation #2 as amended, and to accept the committee's going on record for supporting the "offseason practice" plan proposed by the Athletic Directors Advisory Committee.

Davis presented the Board with one recommendation from the Spirit Advisory Committee: The committee recommended that the Board place an item on the 2019 Annual Ballot to define a school dance team season as presented below:

Dance Team - Season: A school dancer's season is defined as the period beginning with the date the student is selected as a member of a school dance team and shall end on the last contest date for which the dance team is representing the school.

Approved the recommendation of the Spirit Advisory Committee as an Annual Ballot.

Mazzocco reported to the Board from the Sportsmanship Advisory Committee with one recommendation: The committee recommended that the Essay

Contest topic for the 2019-20 year be Leadership in school activities looks like what?

Approved the recommendation of the Sportsmanship Advisory Committee.

Seifert presented the Board with six recommendations from the Tennis Advisory Committee: 1) to change the scoring on the back-side(Consolation Bracket) of the State Tennis tournament to 2 out of 3 sets, match Tie Break for third set, NO-AD scoring; 2) that Girls/ Boys Tennis seasons not be switched for the best interest of High School Tennis participation. A document will be provided by the Tennis Advisory Committee to Kenny Seifert to be shared with MSHSAA; 3) to eliminate the height requirement printed on the state flip cards; 4) to expand the posting of line-ups through team Districts and team Sectionals, for schools who are advancing to the next round; 5) posting individual score results for each match. This information would not be available to the public, only the coaches. NO Fines would be assessed; 6) to remove the double exception rule and just use the sum total of rank order for double lineups. If the sum total is of equal value the team with the highest ranked player must play at the higher ranked double position.

Approved recommendations #1, #3, #6, and #4 (as amended), and denied recommendations #2 and #5 of the Tennis Advisory Committee.

Davis presented the Board with four recommendations from the Volleyball Advisory Committee: 1) submitting to the NFHS three proposed rules changes for the 2019-20 school year regarding clarification on solid and non-solid uniforms, when team rosters are to be presented and modify the rule for the serve for the ball to be contacted within 8 seconds; 2) modifying the current state association adoption to allow schools the option for sub-varsity level (i.e. junior high, freshman, junior varsity only) dual matches and tournaments to abbreviate the third set, when played, to be completed at 15 points or 25 points. This modification should be specified in the game contract, the officials' contract and agreed upon prior to the match and/or tournament; 3) utilizing the 3/5 format for varsity level dual and triangular matches only beginning with the 2020-21 school year and continue to allow the option to utilize either the 2/3 or 3/5 format for varsity tournaments; 4) surveying volleyball coaches and administrators regarding their interest in rotating the

top 2 teams in each district to different districts for post-season assignments.

The committee went on record supporting the proposed classification project as well as supporting the proposed change to the Board Policy on Open Facilities.

Approved recommendations #1, #2, and #3, and denied recommendation #4 of the Volleyball Advisory Committee.

Urhahn shared with the Board five recommendations as Area Meeting Topics: 1) Two-Year Physicals; 2) Link Rule; 3) Open Facilities/Out of Season Contact; 4) Cooperative Agreements; 5) Classification (four options).

Approved the list of items to include as Area Meeting Topics as presented.

Motion Johnson, second Soden, to enter into closed session for matters involving the eligibility status of students where personally identifiable private information from a student's educational record may be reviewed or discussed. Section 610.021(6 and/or 14) R.S.Mo.; 20 U.S.C. 1232g(b); 34 C.F.R. 99.1 et seq. Motion passed 10-0 on a roll call vote with members Soden, Schmidt, Rukstad, Johnson, Linneman, Dittemore, Clemens, Dunham, Wilson and Smith voting yes.

Motion Linneman, second Dunham, to exit out of executive session and closed session. Motion passed 10-0 on a roll call vote with members Soden, Schmidt, Johnson, Linneman, Dittemore, Clemens, Rukstad, Dunham, Wilson and Smith voting yes.

The following action was reported out of closed session.

who have not attended for the past two years and one school who has not attended for three years.

Determined to send a letter regarding the required attendance to the Administrators Rules Meetings to the first and second year schools of missed attendance and send a letter and fine of \$100 per sport and activity registered for the school who has missed attending for three years as well as suspend their competition in district competition until the fine has been paid.

Urhahn reported that there were no petitions received this year.

Seifert provided the Board with a list of schools who have not submitted fall officials ratings.

Approved taking action on the schools in violation by assessing a \$100 fine.

Urhahn discussed with the Board the dropping of postseason competition in the sport of cross country after the fall deadline.

Approved crediting the fines assessed to schools for dropping sports after the deadline as previously levied, do not fine the cross country schools and to release the cross country assignments later than other fall sports next year.

Urhahn reviewed with the Board a request for Esports as requested by Richland High School.

Determined to place the request for Esports to become an emerging activity on the Annual Questionnaire.

The Board received a request from Clayton high School for evaluating cooperative sponsorship qualifications. This item was approved as an Area Meeting topic earlier. No action taken.

Approved the membership application of KIPP St. Louis Charter High School.

Davis and Urhahn discussed with the Board the proposed concentration system is approve the Board the proposed state volleyball classification system is approved by the membership. If approved, pool play will be eliminated and schools would move to bracket play, similar to other team sports. Matches would be played using the three-out-of-five format rather than the current two-out-of three format. No action was taken pending input and possible voting of the membership on the classification system.

Approved proposal for delaying the release of Cross Country classifications and district assignments to September to allow schools more time to determine if the school will be able to field a team.

Resolved to place an item on the

Annual Ballot to change the wording of By-Law 5-5-1-b and to allow the Executive Director to determine on a case by case basis whether a school in violation of removing their team from the field of play should meet with MSHSAA executive staff or meet with the MSHSAA Board.

Long, Stahl, and Garner presented the summaries of proposals received in response to the Request for Proposals (RFP) to serve as the state championship venues in the sports of Softball, Golf and Soccer. The results of the RFP to serve as the state championship venue in the sport of Baseball will be presented at the January meeting of the Board of Directors.

Approved the following sites eleven sites to be used in the rotation for the Boys and Girls State Golf Tournaments for the years 2020-21 through 2024-25: Rivercut Golf Course, Columbia Country Club, Country Club of Missouri, Dalhousie Golf Club, Crown Pointe Golf Club, Paradise Pointe Golf Club, Meadow Lake Acres Country Club. Silo Ridge Country Club, Sedalia Country Club, Twin Hills Golf and Country Club, and Fremont Hills Country Club.

Approved the St. Louis Scott Gallagher Foundation soccer facility as the state championship venue for both boys and girls state soccer tournaments for the years 2020-21 through 2024-25.

Approved the City of Springfield and the Springfield-Green County Park Board proposal of Killian Softball Complex as the state championship venue for both the fall and spring state softball championships for the years 2020-21 through 2024-25.

Urhahn shared with the Board the concern of increased fighting at game contests. It was suggested that an Area Meeting Topic be added to address this situation. The need to protect officials, to provide supervision at games and to require coaches to control their teams were all thought to be valid issues.

Resolved to include a discussion item at the Area Meetings to add more to the by-laws as a deterrent to teams engaging in a fight.

The Board received a state Wrestling Championship lodging and pass request to submit to the MSHSAA office.

Motion Johnson, second Linneman, to enter into closed session for matters involving the eligibility status of students where personally identifiable private information from a student's educational record may be reviewed or discussed. Section 610.021(6 and/or 14) R.S.Mo.;



# Basketball Pregame and Halftime Warm-up Procedure


In some areas of the state, some traditional pregame and halftime warm-up rituals are creating problems for schools and school administrators.

First, it is recommended that teams not be permitted to warm up at halftime of the game that precedes theirs (halftime of the junior varsity game in a JV-varsity doubleheader, etc.).

Next, the NFHS Basketball Rules Book states that home management will designate the location of each team's bench. The rules also state that the pregame practice and first half basket for each team is the one farthest away from its bench. Teams are to conduct pregame and halftime warm-up on their half of the floor only.

If jogging or running is part of their warm-up drills, then it is to be confined to their half of the court. Teams are to refrain from circling the entire floor when they enter the court to warm-up. Officials are to enforce this once their jurisdiction begins by rule by assessing the head coach an indirect technical foul.

Teams leaving their locker rooms and entering the court are to proceed to their warm-up end of the court by the most direct route and at no time are they to pass underneath their opponent's basket. Baiting and taunting of opponents continues to be a problem in some areas, and conducting a segment of a team's warm-up activity in the opponent's end of the court has the potential to encourage poor sportsmanship.

MSHSAA and the NFHS support prohibitions by educational institutions, amateur and professional organizations, and governmental regulators on the use of anabolic steroids and other controlled substances, except as specifically prescribed by physicians for therapeutic purposes.
