The following are questions and answers pertaining to the MSHSAA Constitution and By-Laws and/or MSHSAA Board of Directors policy. These are provided as an aid in interpreting the rules and regulations which MSHSAA member schools have adopted. If you have a specific area and/or question which you would like explained, contact Dr. Kerwin Urhahn, MSHSAA executive director. Your attention is called to the fact questions and answers regarding interpretations of the MSHSAA Constitution and By-Laws appear following the Constitution Article or By-Law they relate to in the MSHSAA Official Handbook.

Question: Our school has applied and been approved to participate in a cooperative sponsorship in baseball. Our school board now wants to void the sponsorship and enter into a cooperative sponsorship with another school in baseball. May our school do this?

Answer: No. By-Law 1.4.1 provides that two schools may mutually dissolve a cooperative sponsorship but such decision may not occur unilaterally. Further, if a school ends a cooperative sponsorship it may not enter into another cooperative sponsorship in that sport until the next two-year cycle. Therefore, your school cannot enter into an agreement with another school. (By-Law 1.4.1)

Question: School A, a Class 1 school, is bordered by a Class 5 school, a Class 2 school and a K-8 district. School A wants to co-op with the Class 1 school on the other side of the K-8 district which is not contiguous to School A due to the K-8 district. May this occur since there is a Class 2 district which is contiguous to School A?

Answer: Yes, provided cooperatively sponsoring the program(s) with the contiguous class 2 school is not an option as all co-ops must be with mutual approval of both school districts. Your school or the class 2 school is not required to try to co-op with each other. (By-Law 1.4.1)

Question: A small Class 1, Grades 7-12 member school, has a junior high basketball season with a team comprised of grades 7-9. Following the junior high season, the school wants to have a cooperative sponsorship agreement with a neighboring member school in girls basketball to include the ninth graders moving up to the cooperative sponsorship high school team after the junior high season is over. Would this be allowed under By-Law 1.4.1?

Answer: Yes, provided the ninth graders do not exceed the 20-week participation limit, quarter and tournament limitations. (By-Law 1.4.1)

Question: One of our swimmers has approached our principal requesting to miss this upcoming Friday school swimming practice to travel to Oklahoma for a non-school swimming meet on Saturday. Our team has practice on Friday and does not compete until Tuesday. Would it be acceptable for our principal and coach to approve this request?

Answer: Yes. This is not a replacement of school practice and is considered as a case by case request as permitted in the by-law (3.13.2.a) to be addressed by the local school administration. This decision rests with the school.

Question: In the posting of our open facility our softball coach stated "Any girl wanting to play softball may come to the open facility." Is this a proper posting?

Answer: No. The "wanting to play softball" implies future team membership. It is acceptable to say "Open facility for softball play".

They don't make the headlines, their names are not in the box scores and they don't make the all-star teams, but perhaps the most important individuals in high school sports are the contest officials.

These individuals are so important that, in fact, there would be no organized competitive sports at the high school level without the men and women who officiate these contests every day across the country. Subtract the dedicated men and women who officiate high school sports and competitive sports would no longer be organized; they would be chaotic.

In some areas, high school officials are retiring faster than new licenses are being issued. And junior varsity, freshmen and middle school games are being postponed – or even cancelled – because there are not enough men and women to officiate them.

Become An Official - Stay Connected to High School Sports

Anyone looking for a unique way to contribute to the local community should consider becoming a licensed high school official. For individuals who played sports in high school, officiating is a great way to stay close to the sport after their playing days have ended. Officiating helps people stay in shape, expands their social and professional network and offers part-time work that is flexible, yet pays. In fact, officiating is a form of community service, but with compensation.

Another benefit of officiating is that individuals become role models so that teenagers in the community can learn the life lessons that high school sports teach. Students learn to respect their opponents and the rules of the game and the importance of practicing good sportsmanship thanks, in part, to those men and women who officiate. And the objectivity and integrity that high school officials display is an example that every young person needs to observe firsthand. In short, communities around the country will be stronger because of the life lessons that high school officials help teach the next generation.

Officiating is a great way to stay connected to sports and to give back to the local high school and community. We need dedicated men and women to become involved so that high school sports can continue to prosper for years to come.

2018 Board of Directors Elections: Kansas City and South Central, and Northeast Districts

The annual MSHSAA Board of Directors election will be conducted in April in accord with provisions contained in Article IV, Sections 3 and 4 of the MSHSAA Constitution. Member schools from the Kansas City and South Central districts will elect Board members for four-year terms. The Northeast District will fill a vacancy (two-year term).

Primary (nomination) ballots will be e-mailed to member schools in the three districts on February 12 and must be received in the MSHSAA office no later than March 5. The names of the three persons receiving the highest number of votes in the primary election in each district will appear on the final ballot unless there is a tie for the third highest position. In such cases, only the names of the persons receiving the two highest number of votes will be placed on the final ballot.

Final ballots will be on-line for all schools in the four districts on April 2 and must be submitted through the MSHSAA website no later than May 1. All ballots are sent to the attention of the school principal.

Annual Election to Amend MSHSAA Constitution and By-Laws

The 2018 MSHSAA annual election to amend the Constitution and By-Laws will again be held in April. The proposed amendments and background information will be distributed to member schools the last week in March. The Annual Ballot will be on-line the first week in April. All ballots are required to be finalized on-line by the school principal no later than May 1.

2018 Investigative Committee Elections

The investigative committee from each of the eight MSHSAA board districts shall consist of one public school administrator, one nonpublic school administrator, and one at-large school representative.

Each year, one of the members will rotate off the committee and a replacement shall be voted on by the membership. Only self-nominations for the appropriate category for replacement members can be accepted (public member will need to be replaced by a public school nominee, nonpublic member will need to be replaced by a nonpublic school nominee, and an at-large member can be a nominee from either public or nonpublic schools). Each district's nomination ballot will list the specified membership category to be voted on for the respective district for the current year.

The self-nomination ballots will be e-mailed to the member school principals on February 12 and must be received in the MSHSAA office no later than March 5. The ballot listing the nominees received will be on the MSHSAA website for member schools' principals on April 6, with a due date of May 1. Please be certain to participate in these elections.

Coaches and Activities Directors Influence MSHSAA Program

The MSHSAA has advisory committees, appointed by the Board of Directors, for each sport and activity in which district and state events are sponsored. Each committee makes recommendations to the Board regarding matters relating to the sport or activity concerned. Some of these are in the form of regulations for the administration of district and state events which become effective when approved by the Board of Directors. Others involve proposals to amend the Constitution and By-Laws which must be put to a vote of the schools when accepted by the Board. The record shows that approximately 80-percent of the recommendations of these committees are approved by the Board and have resulted in significant changes in the MSHSAA program.

This is the Board of Director's procedure for allowing coaches and those involved at the grass roots level to make contributions. The only concern of the Board is that the recommended changes are acceptable to school administrators and do not adversely affect other activities.

The names of advisory committee members are contained in the manuals published for the sport or activity concerned. Coaches, music directors, and speech directors who desire to have changes considered should contact the person on the particular advisory committee from his or her district. Some advisory committee members hold meetings in their areas at the time of district events to get a consensus from their colleagues. This procedure is encouraged to involve as many persons as possible.

Frequently, suggestions from advisory committees are first placed on the Annual MSHSAA Questionnaire sent to member schools in February each year to get a consensus from the schools to determine whether a proposal is satisfactory. In addition to providing the Board of Directors with information regarding the position of school administrators on the matter, it provides an opportunity for each school to give consideration to proposed changes. School administrators are urged to meet with members of their staffs concerned. This course helps provide programs that are acceptable to the majority of persons who are interested in the educational welfare of our youth.

MSHSAA Board of Directors Policy Regarding Specialized Sport Camp Fees

Provisions contained in MSHSAA By-Laws 3.13.6.b and 3.15.5.e stipulate that fees (tuition) for summer athletic camps shall be provided by the student or the student's parents precludes a school from being involved in any group projects to raise money to pay these fees. This restriction applies to a booster club as well as to school coaches. As far as the restriction on athletes is concerned, it would be permissible for several members of a school team to assemble themselves for the purpose of collectively undertaking work projects such as a car wash, a bake sale or other similar type of activities to earn money which could be applied toward camp fees. Under such circumstances all money earned shall go directly to the student to be used at his or her discretion. If the students assemble themselves collectively there can be no requirement that the money earned must go toward the payment of camp fees. Students cannot be assembled through coordination of the school, booster club, or coach nor can they identify themselves as the school athletic team with the purpose of raising money to attend a sport camp.

Soccer Advisory Committee Summary

Held November 15, 2017, at MSHSAA Office, Columbia

1. Recommend that a drop-down option be available for coaches to input yellow/red cards issued at out-of-state games. This drop-down option would eliminate the need for coaches to e-mail the MSHSAA Office with this information.

Rationale: Currently the schools have to report the cards via email to the MSHSAA Office and the MSHSAA Office then has to input the information. This would allow schools to input the information and eliminate a step for the MSHSAA Office.

2. Recommend to the NFHS that Missouri would support the change to allow teams to wear their dark color uniforms at home.

Rationale: Switch would allow schools to wear their school colors in front of their community.

3. Recommend that MSHSAA survey all head varsity coaches to determine (1) which overtime procedure they prefer for varsity contests: OT and PKs (current procedure) or no overtime (regulation only – end in a tie); and (2) which overtime procedure they prefer for JV contests: no overtime (current procedure) or OT and PKs (like current varsity contests) or going straight to PKs.

Rationale: This would allow the MSHSAA Office to get a snap shot of the entire membership.

4. Recommend that a point of emphasis for officials include enforcing and consistently calling encroachment as well as offside.

Rationale: The point of emphasis will encourage enforcing and consistently calling the two new rules.

Volleyball Advisory Committee Summary

Held November 9, 2017, at MSHSAA Office, Columbia

**** 1. Recommend an item be submitted to the National Federation for the 2018 Volleyball Questionnaire regarding Rule 9-5-7, the Center Line. (This appeared on the NFHS Questionnaire this year).

2. Recommend amending Section 1-E of the MSHSAA Volleyball Manual to reduce the full court warm-up for each team from 6 minutes to 5 minutes. The new warm-up procedure will now be 5 minutes shared ball handling, 5 minutes full court (receiving team) and 5 minutes full court (serving team) plus 1 minute to clear the court for time line-up, National Anthem, etc.

3. Recommend a change in language in Section 1-G of the MSHSAA Volleyball Manual to allow the 3/5 format, at the varsity level only, for dual and triangular matches. See new language below.

Missouri schools may utilize the 3/5 format or the 2/3 format for varsity level dual and/or triangular matches only (not in quads or tournaments). In the 3/5 format, the school to win three sets wins the match and the fifth set, if needed, is played to 15 points rather than 25 points (win by two). Schools and/or conferences may utilize the 3/5 format for one or more of their varsity dual and/or triangular matches, as agreed upon by both schools and officials in advance. The format for the match must be clearly specified on the game contract and the officials' contract prior to the contest. Lower level contest (junior high, freshman, junior varsity) will continue to be played in the 2/3 format only. The 2/3 format will continue to be used in the district and state series until a majority of volleyball playing schools support moving the district and state series to the 3/5 format. 3/5 triangular meets may include only varsity level players. An individual playing multiple levels (i.e. jv and varsity) on the same evening cannot participate in the triangular matches.

4. Recommend the following language be added to Section 1-K, Junior High Competition, of the MSHSAA Volleyball Manual allowing junior high schools the option to play one 'extra set' at the conclusion

of the A team match. Motion passed 6-0. (Lyons not present for voting).

New Section 1-K-2 Extra Set – At the junior high level it would be permissible for the B team dual matches only to play one set, not a complete match, if there are not enough players with sets remaining as per the individual daily set limits in By-Law 3.25.1b for dual competition. All NFHS volleyball game playing rules must be followed. The modification should be specified in the game contract, the officials' contract and agreed upon by both schools prior to the date of the match.

*** 5. Recommend the Officials Advisory Committee discuss adding a drop down box to the officials' evaluation process that would allow volleyball coaches to evaluate the official based upon the position he/she worked (i.e. R1 or R2) for that match.

Weight-Control Requirements in Wrestling

If a coach enters a wrestler into competition against another school prior to that wrestler's name appearing on the school's Alpha List the coach has used an ineligible wrestler. **PENALTY:** 1) That match is forfeited; 2) The coach is ineligible to coach at the next contest at the same level – just as if he had been ejected; and 3) The wrestler is ineligible to wrestle at the next contest at the same level, after having his weight assessed, - just as if he had been ejected.

Each wrestler is required to make scratch weight, at least once, during the regular season once he/she has reached the minimum weight class they plan to wrestle in the District Tournament as determined by their weight management plan. The deadline for a wrestler to weigh-in at scratch weight is January 14, 2018. **Exception: A wrestler who has not been medically released due to injury or an ineligible wrestler gaining eligibility must first complete the weight management assessment by a MSHSAA approved Assessor. The weight class in which the wrestler officially weighs in at for the first time, making scratch weight, on or after January 15 will be considered his/her minimum wrestling weight. All wrestlers qualifying for the exception are required to meet the first weigh-in requirement on or before the Saturday of Week 31 of the Standardized Calendar(February 3, 2018).**

If using the Weight Certification Exception, the school AD and Coach are required to print off the Weight Certification Exception Document located on the Wrestling page of the MSHSAA website, The document must be completed entirely and submitted to the MSHSAA office to the attention of the Assistant Executive Director of Wrestling.

A 2lb. growth allowance will begin on January 15, 2018.

Basketball Pregame and Halftime Warm-up Procedure

In some areas of the state, some traditional pregame and halftime warm-up rituals are creating problems for schools and school administrators.

First, it is recommended that teams not be permitted to warm up at halftime of the game that precedes theirs (halftime of the junior varsity game in a JV-varsity doubleheader, etc.).

Next, the NFHS Basketball Rules Book states that home management will designate the location of each team's bench. The rules also state that the pregame practice and first half basket for each team is the one farthest away from its bench. Teams are to conduct pregame and halftime warm-up on their half of the floor only.

If jogging or running is part of their warm-up drills, then it is to be confined to their half of the court. Teams are to refrain from circling the entire floor when they enter the court to warm-up. Officials are to enforce this once their jurisdiction begins by rule by assessing the head coach an indirect technical foul.

Teams leaving their locker rooms and entering the court are to proceed to their warm-up end of the court by the most direct route and at no time are they to pass underneath their opponent's basket. Baiting and taunting of opponents continues to be a problem in some areas, and conducting a segment of a team's warm-up activity in the opponent's end of the court has the potential to encourage poor sportsmanship.

Wrestling Tournament Reminders

Every year the MSHSAA receives numerous questions about what is permitted and what is not concerning wrestling tournaments. For example, a frequently asked question is how many matches can a wrestler participate in during a tournament? The answer is a maximum of five matches each day of the tournament, excluding forfeits. The following items should answer most questions:

- Tournament Definition: "Any event in which awards are given and /or a champion is determined by any means or any format that involves five (5) or more teams, at one site, on any given date. All other contests at one site, on any given date will count as one non-tournament event." By Law 3.26.1
- Senior High School Wrestling Teams may compete in 15 events (no more than 6 of which may be tournaments).
- There is no limit on the number of teams participating in a tournament provided no team will compete on more than one school day.
- No wrestler shall compete in more than 50 matches, excluding forfeits, prior to the district tournament.

- The MSHSAA State Wrestling Championships will be held at Mizzou Arena in Columbia, February 15-17, 2018, using a double-elimination format with complete wrestlebacks to sixth place with a total of 16 qualifiers in each weight class.

 - Session 1:** Thursday, 10:00 a.m. (Class 1 & 2 first round and first-round wrestlebacks)
 - Session 2:** Thursday, 5:00 p.m. (Class 3 & 4 first round and first-round wrestlebacks)
 - Session 3:** Friday, 9:30 a.m. (Quarterfinals, second-round wrestlebacks, Semifinals and third-round wrestlebacks)
 - Session 4:** Saturday, 10:00 a.m. (Fourth-round wrestlebacks, third-place and fifth-place matches)
 - Session 5:** Saturday, 4:30 p.m. (Finals)

- The district tournament will be held February 9-10, 2018 and will be two-day tournaments comprised of approximately 14-15 schools in each district. The top four place finishers in each weight class will advance directly to the state tournament. If at the district seeding meeting it is determined that there are no more than nine wrestlers in each weight class, the district tournament shall be held on Saturday only.

Board Interpretation on “Halftime Shootouts”

Following is an interpretation of the MSHSAA Amateur Awards Standards (By-Law 3.6) as they apply to athletic skill contests. The interpretation was adopted by the Board of Directors at its July 1, 1985 meeting.

“When a student is selected by chance to participate in a carnival type contest involving a skill of a sport, he or she may receive cash or merchandise awards as a result of that participation without its affecting his or her eligibility under the MSHSAA Amateur and Awards Standards. An example of this would be where a student is selected to participate in a half-time promotion at a University basketball game on the basis of a chance drawing of a number on a program which he or she purchased at the game.

In cases where such activities are scheduled and a student is required to enter for the purpose of competing for a cash or merchandise award, such activity would come under the restrictions of the amateur and awards standard and a youngster would jeopardize his or her eligibility in the sport concerned by competing for or accepting such awards.”

State Music Festival Scheduling

Problems scheduling performances at the MSHSAA State Music Festival due to local conflicts (i.e. proms, musicals, theatrical productions, athletic events, etc.) are becoming more prevalent. Due to the size of the festival, it is impossible to schedule every performance to avoid local conflicts.

School administrators and activities directors are asked to avoid scheduling local events that will conflict with the MSHSAA Music Festival performances. The dates of the 2018 Festival are scheduled for April 26-28.

Music directors should also be aware that with approximately 9,000-10,000 students participating at the State Festival each year, some events from your school may be scheduled at the same time. It is impossible to build a schedule that will allow every director to hear each entry. Therefore, schedule changes will only be made if there is a direct conflict with an accompanist or a student scheduled for two events during the same time period. Please remember that an individual may accompany no more than 20 entries per day at the district and state music festivals.

Due to the number of participants at the State Festival, the MSHSAA staff will not be able to honor specific performance time requests. In an effort to assist school administrators and music directors in making appropriate plans for the event as far in advance as possible, a brief summary of the scheduling process is being presented.

Schools should plan to have their schedule encompass the amount of time indicated below. These performance schedules are based on the average amount of time necessary to accommodate the entries as listed.

- 40 or more entries allow 8 hours
- 30-39 entries allow 7 hours
- 20-29 entries allow 6 hours
- 10-19 entries allow 5 hours
- 6-9 entries allow 4 hours
- 5 or fewer entries allow 3 hours

Schools spending the night prior to their performance date should plan on beginning early in the morning. Schools spending the night the day of the performance should plan on performing through the end of the day. Schools with many entries will

be scheduled to occupy the mid-morning through afternoon time slots.

When listing accompanists, it is very important that only a true accompanist is listed. If directors list themselves and are not truly accompanying the performance, scheduling problems for their school and other schools may occur. Please list events appropriately. Your cooperation is appreciated.

As a reminder please review the MSHSAA State Solo and Small Ensemble Festival Assignment by Day link located on the music activities page of the MSHSAA website. Beginning with the 2017-18 school year the three day MSHSAA State Music Festival schools will be divided equally across the three days. Each group will rotate the following year to the next day. For example, schools in Group A will attend state on Thursday for 2018, Friday for 2019 and Saturday for 2020. The cycle will repeat for 2021 back to Thursday for Group A. If you are unsure which day you are assigned, go to the Music Activities link of the MSHSAA web site (www.mshsaa.org). If your school is not listed, the school did not register for music for the 2017-18 school year, and you should contact the MSHSAA immediately.

Parental Permission Statement Reminder for Spring Sports

MSHSAA By-Law 3.7 requires each student participating in interscholastic athletic competition to furnish a statement, signed by the student's parents or guardians, which grants permission for the student to participate in interscholastic athletics. As an aid to member schools in complying with this requirement, the MSHSAA includes a recommended parental permission statement on the MSHSAA physical examination form, available on the MSHSAA Web Site.

Included as a part of the recommended parental permission statement is a statement acknowledging that the parents consent for the student to accompany the team on trips. It further acknowledges that in case of a medical emergency where the parents cannot be reached, the school official with supervisory responsibility for the individual student or group of students on the trip is authorized to obtain emergency medical assistance through a physician or hospital of the supervisors choice which would be considered reasonably necessary for the welfare of the student.

While the parental permission form is required of all athletes, MSHSAA By-Laws do not require them for students participating in nonathletic activities or for students who serve in a support capacity for an athletic team such as statistician, manager, etc. However, the MSHSAA has been advised of a medical emergency that arose involving a student who was accompanying an athletic team to videotape games. Unfortunately, the school in question did not have a parental consent form signed for the student which authorized the school supervisor to obtain emergency medical care. Luckily, the school was able to contact the parents and obtain this permission by telephone after a significant delay.

Because of this experience, it is strongly recommended that school administrators require that signed parental permission statements be on file for all students who travel as a part of an official school party to participate in any type of interschool activity. This will authorize school representatives to seek medical help in emergency situations. These signed statements should accompany the school supervisor on every school trip. It may be of further assistance to have these forms notarized.

Spring Tryouts for Sideline Cheer and Pom/Dance Teams Require Physicals

The MSHSAA Board of Directors has interpreted By-Law 4.5.6 to include tryouts as a recognized event for sideline cheerleading and dance teams. School administrators and event sponsors should be certain all students involved in the tryouts provide a physician's certificate stating that the individual is physically able to participate in sideline cheerleading or dance activities as required **prior** to participating in any activities in preparation for tryouts. This would include practices.

It should be noted that cheerleading and dance physicals issued on or after February 1, 2018, are valid for the remainder of the current school year and all of the upcoming school year (2018-2019).

To keep problems at a minimum, please provide advance notice of this requirement to interested students to allow sufficient time for physicals to be obtained prior to practices and tryouts.

In addition, only students who are currently enrolled at the member school may participate in spring tryouts. Students who may be transferring from another school district into your district for the fall semester are **not** eligible to participate in spring tryouts.

the student must sit out three contests to equate for the three played while ineligible; Harrisonville - Self-reported a violation of By-Law 6.1.2, accepted school's actions, no forfeitures required; Helias - Self-reported a violation of By-law 3.23.1.b, accepted the school's actions, the school to forfeit the game where the violation occurred, student may only participate in five total quarters this week; Herculanum - Self-reported a violation of Board Policy #31 on Public Criticism, accepted school's actions, no forfeitures required; Joplin - Self-reported a violation of By-Laws 2.2.2 and 2.2.5, accepted school's actions, no forfeitures are required, the student is ineligible until all conditions are met from the courts, once that is complete the student must sit out the next seven games before becoming eligible to compete in interscholastic competition; Nixa - Self-reported a violation of By-Law 3.25.1.b, accepted school's actions, the school to forfeit the match in violation, the student in question is to be restricted to three sets in the next regularly scheduled game; Lebanon - Self-reported a violation of Board Policy #27, did not accept the school's actions, no forfeits necessary, speaking to coach is not enough action, the boys basketball program should not be allowed to conduct open facilities for the remainder of the fall semester of the 2017-18 school year unless directly supervised by the athletic director to ensure it is only free play; Northeast (Kansas City) - Self-reported a violation of By-Law 3.10.4, accepted school's actions, no forfeits required, student is fully eligible; Northwest (Cedar Hills) - Self-reported a violation of By-Laws 3.10.4 and 3.4, accepted schools' actions, no forfeitures are required as the transfer ruling the student fully eligible, no eligibility restraints for student; Park Hill - Self-reported a violation of By-Law 3.5.1, accepted school's actions, to forfeit all games played by ineligible student; Parkway West - Self-reported a violation of By-law 3.1.3, accepted school's actions, no forfeitures are required by the school, all students made ineligible by the unapproved coach to be reinstated, coach to appear before MSHSAA Board to show why he should be approved under By-Law 3.1.3 if he desires to be a MSHSAA approved coach in the future; Plattsburg - Self-reported a violation of By-Law 3.9, accepted school's actions, school to forfeit contests in which the ineligible student participated, student to be reinstated once 14 days of conditioning is met; Riverview Gardens - Self-reported a violation of 3.29.3.b, school to forfeit contest in tournament where violation occurred, reinstate students that played in ineligible tournament, school to only schedule two tournaments and 16 regular season

games next year; St. Mary's (St. Louis) - Self-reported a violation of By-Law 3.9, accepted school's actions, school to forfeit game played by ineligible player, student to be reinstated after he has completed the required number of practices; Sikeston Jr. H. - Self-reported a violation of By-Law 3.23.1, accepted school's actions, school to forfeit second contest where the violation occurred, students' eligibility to be reinstated; Whitfield - Self-reported a violation of By-Law 3.12.4, accepted school's actions, no forfeitures required, students' eligibility reinstated retroactively at Whitfield; Willard - Self-reported a violation of By-Laws 3.4 and 3.10.4, accepted school's actions, no forfeitures required, student is fully eligible.

Recommend action by school be accepted and administration acknowledged for self-reporting with no further action – Belton MS - Self-reported a violation of By-law 3.1.4, accepted school's actions, no forfeitures required, the coach is to take the Fundamentals of Coaching Course; Helias Catholic - Self-reported a violation of By-Law 3.14.7.g and the Open Facility Board Policy, accepted school's actions, no forfeitures required, students to have their eligibility reinstated, MSHSAA staff to meet with coaching staff to review rules; Stockton - Self-reported a violation of By-Law 2.2.3, accepted school's actions, school to forfeit the ineligible student's standing and any medal awarded to the student, the student must serve school discipline and sit out one additional contest once he has become eligible.

Determined to institute the investigative committee to review the reported violations of Liberty High School.

Resolved to accept the action taken by St. Pius X (Festus) High School outlined in a letter from school.

Approved the July, August, September, and October 2017 financial statements as presented.

Granted permission for MSHSAA to contact schools with aged receivables to remind the school that post-season status is on hold until payment is made.

Urhahn updated the Board on the current status of the HVAC system in the building. No action taken.

Approved moving forward with the foundation repair project needed for the MSHSAA building.

Garner presented to the Board three recommendations from the Athletic Directors Advisory Committee: 1) including court appointed legal guardianship into the definition of immediate family; 2) permitting

junior high schools to co-op with multiple schools in the same sport as long as the student would not be allowed to change schools they participate with between their 7th and 8th grade school years; 3) moving the start date for winter sports season back on week.

Took the following action on the Athletic Directors Advisory Committee recommendations: Place item #1 on the Annual Ballot, place recommendation #2 on the Annual Questionnaire, and place recommendation #3 on the Area Meetings Agenda.

The Board reviewed the Public/Nonpublic Advisory Committee Minutes. The committee had no recommendations.

Garner presented four recommendations to the Board from the Soccer Advisory Committee: 1) that a drop-down option be available for coaches to input yellow/red cards issued at out-of-state games. This drop-down option would eliminate the need for coaches to e-mail the MSHSAA Office with this information; 2) to the NFHS that Missouri would support the change to allow teams to wear their dark color uniforms at home; 3) that MSHSAA survey all head varsity coaches to determine (1) which overtime procedure they prefer for varsity contests: OT and PKs (current procedure) or no overtime (regulation only – end in a tie); and (2) which overtime procedure they prefer for JV contests: no overtime (current procedure) or OT and PKs (like current varsity contests) or going straight to PKs; 4) that a point of emphasis for officials include enforcing and consistently calling encroachment as well as offside.

Approved all four recommendations of the Soccer Advisory Committee.

Mazzocco presented the Board with one recommendation from the Softball Advisory Committee: The committee recommend adding two additional games to the schedule on days without school.

Denied the Softball Advisory Committee's recommendation.

The Board reviewed the Spirit Advisory Committee Minutes. The committee had no recommendations.

Mazzocco presented the Board with two recommendations from the Sportsmanship/Citizenship Advisory Committee: 1) that the Essay Contest topic for the 2017-18 year be How Would You Use Social Media to Promote Sportsmanship and Positive School Spirit?; 2) that the Essay Contest topic for the 2018-19 year be How Does Participating in School Activities Assist in Developing Positive Character?

Approved both recommendations from the Sportsmanship/Citizenship Advisory Committee.

Seifert presented seven

recommendations to the Board from the Tennis Advisory Committee: 1) the Ad Hoc Committee consider dividing Tennis into three classes; 2) allowing the Tennis Coaches the opportunity to enter their line-ups even after they have been fined for missing the deadline; 3) Rotating Individual Sectional Qualifications on the rotation basis as team sectional qualifications; 4) a change in the language in section 1-O-2 in the MSHSAA Tennis Manual to clarify Singles and Doubles line-Ups. See new language below:

A - Singles line-ups MUST be played as follows:

2. Single players must play in rank order line-up. The line-up shall always be based on the order of ability (rank order). "Matching up" is prohibited. In singles, players must compete in order of rank ability with the best player, based on challenges and match results, being played at number one, etc. In case of injury or sickness, all players must move up in the line-up, not in the rank order.

B - Doubles line-ups MUST be played as follows:

I. Doubles line-ups will be determined by the sum total of the singles rank order value. Example: If the #1 and #2 singles play together their sum total is 3 points. If the #3 and #4 singles play together their sum total is 7 points. Therefore, # 1 and #2 must play at the #1 doubles spot; #3 and #4 must play at the #2 doubles; etc.

II. When the sum total of the teams are the same, (example #3 and #4 play together and #2 and #5 play together-both teams point value is 7), the team with the highest ranked player must play at the higher doubles position. Therefore, #2 and #5 would play at the #1 doubles spot; #3 and #4 would play at the #2 doubles spot; etc.

5) adding language in section 1-L of the MSHSAA Tennis Manual to address Coaching. See new language below:

Coaches may ONLY coach on the court, when seated on a facility provided coach's bench. ONLY OFFICIALS can stand at the net post.

In addition, the committee requests that the ORR addresses the following: Coaching your players must be done in a way that it does not have an effect on your opponents.

6) a change in language in section 1-O-4 of the MSHSAA Manual "appeals concerning unfair line-ups". See new language below.

4. Appeals challenging unfair line-ups: If a coach feels that the opponent's lineup as presented is unfair, he/she MUST verbally notify the opposing coach of the challenge prior to the start of the dual match. If a coach does not verbally notify the opposing coach of their challenge of an unfair line-up prior to the start of the match, there can be no appeal. In addition to the coach verbally

informing the opponent of their challenge, any coach who wishes to submit an official written match appeal (after the completion of the match) must first inform the opposing coach in writing (by fax or e-mail), with a copy sent at the same time to the MSHSAA Office. The written appeal must be made within 48 hours after the match was played. The MSHSAA office will require clear proof of an unfair line-up/stacking prior to taking action.

7) extending the date by which tennis coaches are required to "Freeze" their singles rank order; 8) adding a tennis preseason scrimmage; 9) having no coaching restrictions.

Approved recommendations #1 through #7 and denied recommendations #8 and #9 from the Tennis Advisory Committee.

Davis presented the Board with five recommendations from the Volleyball Advisory Committee: 1) an item be submitted to the National Federation for the 2018 Volleyball Questionnaire regarding Rule 9-5-7, the Center Line. (This appeared on the NFHS Questionnaire this year); 2) amending Section 1-E of the MSHSAA Volleyball Manual to reduce the full court warm-up for each team from 6 minutes to 5 minutes. The new warm-up procedure will now be 5 minutes shared ball handling, 5 minutes full court (receiving team) and 5 minutes full court (serving team) plus 1 minute to clear the court for time line-up, National Anthem, etc; 3) a change in language in Section 1-G of the MSHSAA Volleyball Manual to allow the 3/5 format, at the varsity level only, for dual and triangular matches. See new language below. Missouri schools may utilize the 3/5 format or the 2/3 format for varsity level dual and/or triangular matches only (not in quads or tournaments). In the 3/5 format, the school to win three sets wins the match and the fifth set, if needed, is played to 15 points rather than 25 points (win by two). Schools and/or conferences may utilize the 3/5 format for one or more of their varsity dual and/or triangular matches, as agreed upon by both schools and officials in advance. The format for the match must be clearly specified on the game contract and the officials' contract prior to the contest. Lower level contest (junior high, freshman, junior varsity) will continue to be played in the 2/3 format only. The 2/3 format will continue to be used in the district and state series until a majority of volleyball playing schools support moving the district and state series to the 3/5 format. 3/5 triangular meets may include only varsity level players. An individual playing multiple levels (i.e. jv and varsity) on the same evening cannot participate in the triangular matches; 4) the following language be added to Section 1-K, Junior High Competition,

of the MSHSAA Volleyball Manual allowing junior high schools the option to play one 'extra set' at the conclusion of the A team match. Motion passed 6-0. (Lyons not present for voting). New Section 1-K-2 Extra Set – At the junior high level it would be permissible for the B team dual matches only to play one set, not a complete match, if there are not enough players with sets remaining as per the individual daily set limits in By-Law 3.25.1b for dual competition. All NFHS volleyball game playing rules must be followed. The modification should be specified in the game contract, the officials' contract and agreed upon by both schools prior to the date of the match; 5) the Officials Advisory Committee discuss adding a drop down box to officials' evaluation process that would allow volleyball coaches to evaluate the official based upon the position he/she worked (i.e. R1 or R2) for that match

Approved recommendations #2, #3, #4 and approve recommendation #5 as amended from the Volleyball Advisory Committee. (No action was taken on recommendation #1.)

Maurer presented two recommendations to the Board from the Cross Country Advisory Committee: 1) to include in the Manager's Manual: District and Sectional hosts are expected to provide an adequate number of marshals, placed in strategic locations throughout the cross country course; 2) to include in the Manager's Manual: The first race of the day should be scheduled for 10:00 a.m., with consideration being given if any team must travel more than 100 miles.

Approved both recommendations from the Cross Country Advisory Committee.

Urhahn presented topics to the Board for possible Area Meeting Topics this year. The Board discussed the following topics:

Determined to send a letter of reprimand to the schools not attending a required administrators rules meeting this year for the first year and a letter to those schools not attending a meeting for two years indicating that a third year of no attendance would suspend the school from state series competitions and fine the school \$100 per activity or sport the school is registered in.

Urhahn updated the Board on the current petition being circulated for six classifications for basketball. The deadline for receipt of the signed petitions is December 15. No action was taken.

Seifert updated the Board on the number of schools failing to submit the required official's ratings for fall sports. No action was taken.

Determined to inform McCluer High School that the transfer student in question is not eligible until the school can confirm the student does live within its attendance area.

Resolved to send letters to Normandy Collaborative and Alta Vista Charter high schools informing them that their schools are suspended from winter postseason until the Institutional Certificate of Compliance is completed.

Approved the mid-cycle cooperative agreement for baseball between Grundy County and Newtown-Harris high schools.

Approved the privacy policy for the MSHSAA website as presented.

Urhahn discussed with the Board a policy on collecting enrollment data on shared students and alternative school students. No action was taken.

Urhahn discussed with the Board the possibility of moving the March Board of Directors meeting from Wednesday to Thursday. It was confirmed by consensus to have the March meeting on March 8 beginning at 10:00 a.m. in conjunction with the state basketball championships in Springfield.

Placed the Glendale High School football program on probation. As a condition of probation, the varsity head coach and player must sit out the first game of the 2018 season, no forfeitures are to be required of the school.

Determined to take no action on the request from Barstow High School to change the by-laws for Speech/Debate/Theatre. Urhahn presented a reported violation involving Fair Grove High School to the Board.

Determined to take no action on the reported violation of Fair Grove High School.

Approved the dissolution of the cooperative agreement between College Heights Christian and McAuley Catholic high schools for music.

Approved the report from the St. Louis Investigative Committee involving undue influence from Francis Howell Central High School to Christian Brothers College High School.

Approved renewal the MSHSAA Medical Insurance Policy with the current insurance carrier.

Accepted the proposal from the Columbia Convention and Visitors Bureau and the

University of Missouri - Columbia to host the State Wrestling Championships for the five school years 2018-19 through 2022-23.

Accepted the proposal from the Jefferson City Convention and Visitors Bureau and the Jefferson City Public Schools to host the State Track and Field Championships for the five school years 2018-19 through 2022-23.

Accepted the proposal from the Columbia Convention and Visitors Bureau and the Columbia Parks & Recreation Department to host the State Cross Country Championships for the five school years 2019-2020 through 2023-24.
