## **NFHS Online Sanctioning Process**

The NFHS has an online sanctioning process for events which require NFHS approval. Interested individuals who plan to host an event will go online at the NFHS website (www.nfhs.org), register as an event manager (if you have not already done so), create an event and complete the online application. An e-mail is then sent to the host school's principal and host state association. The state association reviews the application online including the list of invited schools and determines if the event will be approved or denied. Once approved the event sponsor is notified that payment is required. **Credit card and electronic check are the only forms of payment accepted.** Once payment is received by the NFHS, the invited states/schools are notified and the event is listed on the NFHS website. As the invited states respond to the sanction it is automatically updated on the NFHS website. Once every invited state has responded, the application is approved and sanctioned by the NFHS staff.

**Events that require NFHS sanctioning:** (Refer to Appendix E of the MSHSAA Official Handbook for additional information)

- Any interstate event involving two (2) or more schools which is co-sponsored by or titled in the name of an organization outside the high school community (e.g. a university, a theme park, an athletic shoe/apparel company).
- Non-bordering events if five (5) or more states are involved.
- Non-bordering events if eight (8) or more schools are involved.
- Any event involving two (2) or more schools that involves a team from a foreign country. The host school should complete the international sanction request via the NFHS website. (Exceptions: Canada and Mexico which are considered 'bordering states')
