# **HISTORY OF ADVISORY COMMITTEES**

The MSHSAA Board of Directors in the late 1950's was concerned with comments from coaches, music and speech directors indicating they had little voice in the administration and regulations of the respective activities they directed in their schools. To address this issue, the Board was to appoint advisory committees for music and speech to assist the Executive Director and Board of Directors in planning and administering the various activities.

The MSHSAA Constitution, after a vote of the member schools, included provisions for music and speech advisory committees. However, specific procedures for implementing the committee recommendations were not addressed. In 1959 the Music Advisory Committee was the first to become active and met with the executive director to review the regulations applied to music festivals and to make recommendations to the Board via the Executive Director for improvements in the program.

Shortly after the Music Advisory Committee became active the Speech Advisory Committee followed suit. The first significant recommendation was to include all speech activities, rather than debate only, under the jurisdiction of the MSHSAA.

The hard work and promising recommendations made by these two advisory committees prompted the Board of Directors to establish similar advisory committees in each activity under the MSHSAA jurisdiction. As new activities have been added or expanded, advisory committees have continued to be developed to meet this growth.

# PURPOSE OF ADVISORY COMMITTEES

The advisory committees serve to provide increased communication from the "grass roots" level between the MSHSAA member schools and the MSHSAA Board of Directors. The committees shall act in an advisory capacity with the MSHSAA Board of Directors reserving the right to accept, reject or amend committee recommendations.

## Agenda Item:

Develop "Gold Medal Music School" status for schools that participate in large ensemble festival.

# Rationale:

Each year it seems more schools are choosing to not participate in large ensemble festivals. So I have been

reflecting on how we can incentivize schools to engage in this worthwhile event. What I have come up with is the following:

For high schools whose bands, choirs and orchestras (if they have one) participate in MSHSAA large ensemble festival, MSHSAA would recognize that school's music program as a "Gold Medal Music School". All of their music programs would need to participate; it would not recognize individual band or choir programs. You could further recognize programs based on ratings, number of large ensembles participating or other level of activity such as an active jazz band, winter guard, winter percussion, show choir, honor performances, etc as a "Gold Medal Music School, with Distinction". This would be cost free to MSHSAA. An email to administration and an icon for their school website. Maybe offer a plaque that can be ordered along with other music awards.

The question I ask myself is if this would create an incentive for directors to chose to participate? Does it also (and I am not sure if this would be considered good or bad) create a bit of pressure within the school by administration to have their directors participate?

It is important to note that this idea is not punishing any school or group that continues to not participate in MSHSAA large ensemble festivals. Nothing changes for those schools. But for the schools that ARE making the choice to support MSHSAA, they earn a recognition for those efforts.

Another idea would be to perhaps create a discounted rate on State solo/ensemble entries for those schools who participate in large ensemble festival. This may not be feasible due to the cost factor however.

## Agenda Item:

Vocal Large Ensemble Sight Reading regulations- regardless of class, SAB sight reading should be an option.

#### Rationale:

As we all know, male singers (especially tenors) are always in short supply, whereas female singers are often plentiful. Requiring SATB sight reading forces a director to have female altos sing the tenor part which is not educationally appropriate for most students.

Example 1: 2 years ago we had 2 tenors total in our group. Having just 2 people sight read on a part against a large amount of Sopranos and Altos was difficult enough. Unfortunately, both of them became ineligible to perform in Large Ensemble. This left me to ask a handful of altos to sing tenor at the last minute. This was not a good educational model for anyone and the extra pressure they felt could have been avoided had we been allowed to sing SAB.

Example 2: Last year, we had a very small group of male voices (all of whom were baritones) and I made the decision to sing SSAB music at large ensemble. Developmentally, this was the best situation for all of my students. We were again faced with having to sight read in SATB, which was not ideal for their development.

Sight Reading should measure musical progress that is both developmentally and educationally appropriate. The current rule and format is not ideal for many groups and does not measure what we are trying to achieve."

According to several websites, including MTNA, photocopies of purchased solo music books to facilitate difficult page turns IS, in fact, allowed under copyright law. -

There is no reason for a student or school to purchase 4-5 solo books for ONE student to use for ONE solo, and have to use 3-4 music stands for that student to put all of the books on. Furthermore, this one student has to put their fingerings and bowings into these several different books for the corresponding page on the various music stands. It's crazy. This has happened to several of my students who have long solos from one solo book. Other state competitions and universities allow photocopied page turns.

Website usability revision & Music Manual formatting.

Rationale:

The following is likely low on the totem pole compared to 'policy', and to some it might be perceived as negligible. Two practical issues make the use of MSHSAA information challenging, at least as it relates to music.

Website, including the Festival Manager. Usability is pretty low. When one gets penalized because of a tool's low usability -- one published by the authority -- on something we might use once or twice a year in differing capacities, the extra steps and unclear workflow of the current situation are off-putting, and the results can appear unjust.

Music Manual. All rule books become full of a thousand qualifications, and both the tax code and Music Manual seem afoul of Occam's Razor. I get why it happens. But if we are not to simplify things, we can at least have formatting that is not overly busy, easy to read, and more helpful in the promotion of discernment. We are no longer printing the phone book, and digital space and resources are plentiful. A clean version of the Music Manual seems possible. Certainly, there is someone whose talents and joys in their work include digital formatting. For the sake of the corporation of users, investment in those talents with the pursuit of helpful readability is worthwhile.

The prioritizing of such things would bring great service to the members. Bringing enhanced usability and accuracy in their use would certainly help our friends at MSHSAA and make their job easier. As this is the goal of MSHSAA policy: a quality experience for the students and all who work with them, it would seem to be a reasonable ask for the dedication of some resources to these two items.

I have a lot of students that would benefit from a comments-only option for their first attempt (or subsequent attempts) at attending solo/ensemble contest. Freshmen or first timers, would be more encouraged to participate if the first go was unrated. Our IEP students who would not ever receive a Exemplary or Outstanding rating deserve to have a setting where they can receive positive feedback from a judge in the areas where they excel in their performance without receiving a rating titled "Satisfactory", "Developing", or "Ineffective". Those ratings can be really damaging and discouraging for those kids. I know some districts already do a smaller version of solo/ensemble in house, but not everyone has the capability or funds to do that.

# Agenda Item:

Allow Class 5 bands with significant personnel, program, and/or instrumentation issues to petition for a more realistic sight-reading experience. (ex. down a class based on instrumentation and/or prepared music grading)

## Rationale:

Please consider the discrepancy in equity among Class 5 schools in sight reading. If a student were to come from a Class 5 school with enough students to fill 2-3 ensembles, a class 5 student may only be asked to read to the instrumentation and rubric of a Class 3 or Class 2 student. However, if another class 5 school has been unable to support a healthy music program, the students available to fill out a single ensemble will be asked to read at the Class 5 rubric, regardless of whether they have the instrumentation to do so successfully. There is already a condition in place for Class 5 groups of varying capabilities within the sight-reading rules as the second and third ensembles (with acknowledgement of the accommodations for students enrolled in multiple ensembles). I hope we can find a way to allow underserved students at these large schools to have a more representative sight-reading evaluation, either by classifying the prepared music they are bringing, or by instrumentation.

I would like to propose a rule revision in Section 5. D. of the music manual stating that all snare solo and any ensembles using snare drum must be performed on mylar drum heads, and the use of kevlar would result in an automatic disqualification. Now that percussion solos/ensembles are in the Sinquefield Music Center and are no longer in Memorial Union, I don't see any rational reason as to why we are enforcing this rule. The notion that mylar drum heads would create lower decibels in an enclosed space is simply not true, and I made

a video with a student in the Spring of 2024 to prove this. See the link to that video below:

Rationale:

The modern snare repertoire that is on our state list was written to be performed on kevlar heads, and I believe we are doing a disservice to our students by forcing them to play on an instrument that makes it harder to read the density and clarity of these modern solos. Agenda Item:

I would like to suggest that the rule about pianists being required to be in a performing ensemble be re-

evaluated. I know this has been a long standing rule-since I was in high school 20 years ago, but I knew then and see now some negative effects on students.

Recommendation: Pianists be allowed to participate in MSHSAA solo and small ensemble festival if they

- a) meet all eligibility requirements to participate in a school's ensemble
- b) an ensemble director is willing to sponsor their performance/attendance at festival.

## Rationale:

We have a number of pianists in our small school and a very tight/limited schedule. Students who would like to take a piano solo to festival every year, can not do so in our school unless they choose to participate in choir each year which would exempt them from every getting to take studio art or photojournalism in high school. Not all of our pianists have the time or skill to prepare for festival AND accompany another student, but many of them are engaged in our student body by accompanying our grammar school chapel hymns, and playing in our worship team sporadically through the year. It would be a blessing to give our pianists a chance to be a part of this if they choose a different fine art course during our school day.
