



MSHSAA Prescribed Graded Music List Submission Cycle and Information

Submitting literature for consideration to be placed on the MSHSAA PGML **is on an established 3-year rotation for each area of the list.** Literature may be submitted anytime throughout the year; however, it will be kept on file until the next review cycle for that specific area. All music is submitted via the MSHSAA Website and should be submitted by a registered music director.

The MSHSAA encourages the submission of works from underrepresented composer groups and/or cultures. The MSHSAA does not discriminate on the basis of race, color, national origin, sex, disability, or age in its programs.

Percussion-Mallet Solos & Timpani Solos**

**Materials must be submitted online via the MSHSAA Website on or
before June 1st the summer of the relevant literature review.**

Music Submitted for Timing Consideration Only

If a director believes a selection on the PML has been timed incorrectly, please submit the selection using the online process. You must note in the submission notes that the piece is already approved on the PML, and you are seeking re-evaluation of the timing. At the appropriate time in the review cycle the selection will be evaluated and an adjustment made if appropriate. Please contact the MSHSAA office if you have additional questions.

Removal of a Selection

If you have a selection that you feel should be removed from the MSHSAA Prescribed Graded Music List, please submit the selection using the steps outlined below to our office for review. Please contact the MSHSAA office if you have additional questions.

- Print and complete a **'Literature Petition Form – Removal of a Selection'** form located in this document for each selection along with any additional documentation.
- Attach a photocopy of the score (ensembles only) or soloist's part with the **'Literature Petition Form – Removal of a Selection'** form and mail to the MSHSAA Office on or before **June 1st**.
- **Do NOT send originals.** All photocopies will be destroyed after the review.
- A **'Literature Petition Form – Removal of a Selection'** form must accompany each title being submitted for review.
