- **Time:** 9:45 a.m.
- **Location:** Finish line

Admission

- **Cost:** \$6.00 (ages 6 and up)
- **Payment:** Cash only at the admissions gate

Spectator Seating

- Bleacher seating is **very limited**. Spectators are encouraged to bring **lawn chairs and blankets**.

Athlete & Staff Entry

- Athletes must be in uniform when entering through the pass gate.
- Coaches, managers, and administrators must be on the pass list submitted by their school. The deadline to submit pass lists is noon on Thursday, May 8th.

Competition & Advancement

- **Top four finishers** in each event will **medal and advance** to Sectionals.

Throwing Implement Inspection

- **Time:** 9:00 a.m.
- **Location:** Shed
Implements will be inspected, weighed, and transported to the event site by meet officials.

Pole Vault

- Coaches will sign in pole vaulters' weights and poles at the scratch meeting.

Event Reporting

- **Field Event Competitors:** Report to the event site when called.
- **Runners:** Report to the bullpen (**northeast corner of the track**) when called.
- **Field Event Warm-Ups:** Not allowed until the official worker is present.

Event Rules & Procedures

- **Throws & Jumps:**
 - **Prelims:** 3 attempts
 - **Finals:** 3 attempts
 - **Top 9 competitors** advance to finals.
- **High Jump & Pole Vault:**
 - Starting heights set by the games committee (announced at the coaches' meeting).
 - MSHSAA rules apply to warm-ups, passing heights, and tie-breaking.

Facility & Equipment

- **Track:** 8-lane, all-weather surface.
- **Spikes:** 1/4" pyramid spikes or smaller only.
- **Starting Blocks:** Provided.
- **Exchange Zones:**
 - **Tennis ball markers** allowed.
 - **Chalk:** Allowed for high jump.
 - **Chalk/markers:** Must be to the side of the runways.
 - **No tape** allowed on the track surface.

Team Camps & Tents

- **Location:** Grass field **north of the track** (above the hill).

Additional Information

- **Concessions:** Available.
- **Hospitality Meal Tickets:** Provided at the coaches' meeting (for coaches and bus drivers).
- **T-Shirts:** Sold at the west end of the shed (limited sizes/quantities).

Bus Parking

- **Drop-Off:** Back of the school parking lot (west end of the high school).
- **Parking:** Buses must exit the school area and park at the softball field.
