 - Recommend action by school be accepted with reprimand issued and administration acknowledged for self-reporting -Clayton - Self-reported a violation of By-Law 3.16.1, accepted school's actions, no forfeitures required, violation cannot occur again – if coach does it again it would result in his approval to coach being removed; Climax Springs – Self-reported a violation of By-Laws 2.2.2 and 2.2.5, accepted school's actions, no forfeitures required, request for lesser penalty tan 365 days of ineligibility is granted, student may be reinstated after he sits out 23 contests; Delta - Self-reported a violation of the MSHSAA Basketball Manual, accepted school's actions, no forfeitures required, accepted self-report of the violation of the Basketball Manual that has been in place for at least 26 years; East Buchanan - Self-reported a violation of By-Law 3.21.1, accepted school's actions, forfeit varsity contest where violation occurred, student only has five quarters at the next basketball contest; Lamar - Self-reported a violation of By-Law 3.21.1, no forfeitures required as the contest was lost, reinstated the student fully after sitting out the one quarter on January 27th, coach may be reinstated after serving the school suspension; Lift for Life Academy Charter - Self-reported a violation of Article III, Section V, accepted school's actions, no forfeitures required, girls are all reinstated and fully eligible; Lift for Life Academy Charter - Self-reported a violation of By-Law 3.1, accepted school's actions, no forfeitures required, coach to be reinstated after he serves school imposed suspension; Lutheran South - Self-reported a violation of By-Law 3.13.1.c, accepted school's actions, no forfeitures required, granted request of lesser penalty than 365 days of ineligibility and reinstate students, coach to be reinstated after sitting out a week of practice and the first regularly scheduled match; North Kansas City (Northgate MS) - Self-reported a violation of By-Law 2.3, accepted school's actions, school to forfeit any event participated in by the ineligible student, student will have to sit out an equal number of contests as he competed in while ineligible; North Technical - Self-reported a violation of By-Law 3.1, school to forfeit December 13th contest that used unapproved coach, Brianna Williams is not to be on the bench during games or in the gym for practices until she is listed as a coach and completed her requirements to be approved. Aaryanna Cook cannot coach until she has completed all the requirements; Parkview - Self-reported a violation of By-Law 2.3, accepted school's actions, to forfeit all contests wrestled in by the ineligible student and return any awards won, student must sit out equal number of contests as competed in while ineligible; Parkway South - Self-reported a violation of By-Law 3.10.4, accepted school's actions, no forfeitures required, student retroactively eligible; Raytown South - Selfreported a violation of By-Law 3.1.5.a.2, accepted school's actions, no forfeitures required, coach not approved to coach in practices or matches until he has completed the requirements in the By-Law and imposed by the school; Rosati-Kain - Selfreported a violation of By-Laws 3.1.3.b, 3.14.2, and 3.13.6, accepted school's actions, no forfeitures required, students and coach to be reinstated after sitting out the school required practices; St. Dominic - Self-reported a violation of By-Law 2.6, accepted school's actions, no forfeitures required, reinstate students; Trenton - Self-reported a violation of By-Law 3.21.1, accepted school's actions, to forfeit contest where violation occurred, student has five quarters available on next competition night; Vianney - Self-reported a violation of By-Law 3.21.1, accepted school's actions, reinstate student to full eligibility after only playing four quarters in the next contest, if violation occurs in the future, a consequence for the coach where the violation occurred will be required.
