

QUESTIONS & ANSWERS

The following are questions and answers pertaining to the MSHSAA Constitution and By-Laws and/or MSHSAA Board of Directors policy. These are provided as an aid in interpreting the rules and regulations which MSHSAA member schools have adopted. If you have a specific area and/ or question which you would like explained, contact Dr. Kerwin Urhahn, MSHSAA executive director. Your attention is called to the fact questions and answers regarding interpretations of the MSHSAA Constitution and By-Laws appear following the Constitution Article or By-Law they relate to in the MSHSAA Official Handbook.

Question: Our school district supports three high schools. Our Board of Education will permit and grant requests from students to attend a high school in which their parents' residence is not located in that high school's established geographic attendance area. The family does, however, reside in the school district. Would this scenario fall within the requirements of residence in MSHSAA By-Law 3.10.2?

Answer: No. The by-laws carefully define residence as being within the established geographic attendance area for the individual member school and not an entire school district of multiple schools at the same level. In the situation described, the students would be initially ineligible until a transfer form is submitted to determine athletic eligibility in all sports. Non-resident freshmen may be ruled eligible under the "promotion" transfer exception, but they are still considered transfer students if they live outside of the individual high school's boundaries, and a transfer request must be filed.

Question: Our school encourages our students to use our weight room for out of season conditioning. Our athletic coaches take roll of their student athletes and expect them to participate in this program. If the students do not attend the coaches counsel with them that they should be there for the good of the team. Is this appropriate action by our coaches?

Answer: No. Participation in an out-of-season conditioning program is completely voluntary and must be open to any student who desires to attend. Taking roll for team attendance is signaling to the students a record of team member attendance is being kept even though the activity is voluntary. The follow-up with the students and so called "counseling" to attend has definitely tied participation with team responsibility outside of the season. The adults have implied to the students they are expected to attend and this is a responsibility to the team.

Because there is a fine line that can be crossed, school administrators must educate their coaches of what is appropriate and must monitor carefully the out-of-season conditioning programs.

Question: Our football coaches have worked out a schedule for the summer and have divided up the duties to give them some time off at home with their families. The head coach is going to work with the team on Mondays and Wednesdays and play seven-on-seven on Saturdays. Our assistant coaches are going to open up the weight room on Tuesdays and Thursdays. We would also like to host our own full contact camp the fourth week in July for four days. a) Do we have to count all of these days as contact days? b) Can our assistant coaches go to the games on Saturdays? and c) when does the summer period end?

Answer: A) the days that the coach or any coach from that sport is giving instruction will be counted as a contact day therefore; the head coach would have to count his days as contact days. If the assistant coaches are following By-Law 3.15 for out-of-sport conditioning they will not be counted towards the contact days. However, if sport specific instruction takes place they will count as contact days. Example: Weight training is over and the kickers go and get a couple of balls and practice kicking out on the field; contact has occurred for that sport. B) Your assistants can attend any function. The school must keep tract of sport specific contact. Any football contact, with instruction is considered one day of contact. You can have three coaches with three different sets of students from the same school doing different things on the same day and that is one day of contact. C) for fall sports the summer ends July 31. For all other sports the summer ends with the Sunday of week six of the standardized calendar.

Question: Who cannot coach a nonschool team during the school year outside a particular sport's school season?

Answer: No member of the coaching staff of any sport (not just the sport in question) from any school that any student on the nonschool team currently attends or will attend the following year can coach this particular nonschool team during the school outside the specific sport's school season (MSHSAA By-Law 3.14.2.e).

Question: Is there a difference to the rule mentioned in the question above if the nonschool competition occurs in the summer after school is dismissed for the summer?

Answer: Yes, during the summer months, the nonschool team participants in any sport may be coached by a member of the schools coaching staff of the school the nonschool participant has attended the previous school year or will attend the next school year (MSHSAA By-Law 3.15.3 Editor's Note).

Summer School Questions

Summer school courses and credit earned may count toward academic eligibility if specific requirements are met. The individual school district must first adopt an official position that summer school credit shall be accepted. The policy on summer school credit should be placed in writing and readily provided for informational purposes to parents and students. It should be made clear that correspondence school courses and electives do not meet this requirement.

The following questions and answers should be helpful and shared with your school counselors.

Question: Will students be able to count summer school credit toward meeting the academic eligibility requirements for the first semester of the 2018-2019 school year?

Answer: Yes. By-Law 2.3 provides students may count up to 1 unit of credit from summer school toward establishing their eligibility for the fall semester. Only classes, which are required for graduation from the local school, may be counted toward meeting the academic requirement. Electives are not accepted.

Question: Should we have some type of a form that our counselors may want to use to advise the student and parents if the class(es) being taken in summer school will or will not count toward regaining academic eligibility?

Answer: Absolutely. The counseling department and the school athletic and activities directors must all work together to be certain students are advised properly before taking the class. If any questions arise the MSHSAA office should be contacted. (573-875-4880).

Question: If a student needs 1 unit of credit in physical education and has earned that credit by the end of the sophomore year, may the student take physical education during the summer after the junior year as an elective and count this credit toward re-establishing his academic eligibility?

Answer: No. Only classes required for graduation as set form by the Department of Elementary and Secondary Education (DESE) and/or the local school may be counted in summer school. Electives would not count toward regaining eligibility.

Question: May one of our students take summer school in another district and count the credit earned towards eligibility?

Answer: Yes, provided the class is required for graduation and your school is going to accept the credit and place on the student's transcript.

Question: If one of our student's fails Algebra I must that student take Algebra I in summer school or could the student take a required science class if Algebra I is not being offered?

Answer: A student is not required to take the same class failed during the school year. The student may retake the class during summer school, but it is not required. The only requirement for a summer school class to be counted towards academic eligibility is that the class is a graduation requirement for the school and cannot be an elective.

Question: Is it mandatory that our school accept summer school credit for determining academic eligibility for the fall semester?

Answer: No. This like all other requirements of student eligibility are the minimum essential requirements and each local Board of Education/ Governing Body has the right to establish more stringent requirements.

Question: What is meant by the core classes required for graduation by DESE?

Answer: In order for all students across the state to meet a minimal curricular program it was adopted by the schools to rely upon core courses and required credits for graduation as required by the Department of Elementary and Secondary Education.

Area Meeting Report

The MSHSAA staff conducted eight Area Meetings during the month of January. Information gathered at these meetings was presented to the MSHSAA Board of Directors at the January, 2018 meeting of the Board. Consideration was given for further action on the topics discussed. Below is a brief summary of discussion and overall opinions on the topics gathered at each of the eight sites.

1. Junior High Academic Standard for Non-Traditional Students

Blue Springs South (Kansas City District):

Number of high school participants - 11. To have: yes - more consistent, no - no credits offered. For - 40, Opposed - 10.

<u>Waynesville</u> (South Central District): Should reflect what we do at the high school. 100% in favor passing.

Cameron (Northwest District):

If a school is permitting Non-Traditional 2 students at the high school level then it would be consistent to permit Jr. high NT 2 students. 1) No schools have NT education taking place (not interested). 2) 50-50 Non-Committal.

McCluer South-Berkeley (St. Louis District):

Very few junior high schools in St. Louis. No real input or discussion.

Republic (Southwest District):

Is Non-Traditional present at the junior high? Be consistent 7-12. In agreement 90%

Smith-Cotton - (Central District):

How mange? One in audience this year in high school. Same rules 7-12. Most regular 7 period day; one on block. Most Ok.

Mexico (Northeast District):

1) One school. 2) 80% yes in favor of applying it at junior high level.

Dexter (Southeast District):

Number of Non-Traditional Students. 100% in favor.

2. Football Activities - Summer (By-Law 3.15.6.a and b)

Blue Springs South (Kansas City District):

Majority in favor of 1st question, not everyone voted, no school opposed. 60% in favor of and 40% opposed to question 2. Afraid of schools going out and playing multiple full contact days with many schools. Thought that 3 may be too much, but wanted to limit the number down from 9. Want to view the 6 days of camp to be at your school with your kids and not consecutive days - 100% in favor of this question. Does not matter whether the university or non-school or private organizer runs it. 100% OK with full contact during the summer.

Waynesville (South Central District):

Q1) Summer acclimatization should mirror fall - 100% agree. Q2) Not crazy about allowing scrimmages during the summer. Not sure it is a good thing. We should look at what is best for kids. Football coaches feel the coaches have the hand cuffs are on. Only votes for not allowing scrimmages. Q3) Everyone was Ok with allowing one for one counting. Would probably allow schools not to do as much during the one day, since it does not count more than one day. Q4) Does not matter who hosts the camp - 100%. 5) No one in favor of eliminating, 3 opposed to eliminating.

Cameron (Northwest District):

Catastrophic Insurance during summer. Struggle finding workers and supervision for summer games. Eligibility issues problems with fans and players. Beneficial for MSHSAA to get insurance. How would you know if a school has insurance. Acclimatization you could get a month off and come back? 1) 100%. 2) 9 favor - everyone else 90 - 10 - No. 3) 90-10 favor 1 day = 1 day. 4) 80-20 favor providing more flexibility. 5) 100% - no do not eliminate.

McCluer South-Berkeley (St. Louis District):

Q1) 100 % support for fall and summer to have the same heat acclimatization. Q2) - What about jamboree style, control scrimmage, not full game. What does the 20 days look like? Why do we need full pads during the summer? No support for full pads complete scrimmages during the summer. They would consider using preseason scrimmages set ups and ok with schools hosting. Q5) 50-50 with a modifications to full contact.

Republic (Southwest District):

Q 1) 95% in favor of acclimatization, 5% opposed. Q2) 100% opposed to full contact games between member schools during the summer. Q4) 80% in favor of more flexibility for universities, 20% treat them the same. Q5) most voted to not eliminate full contact.

Smith-Cotton (Central District):

1) 100% supportive of adding requirements for heat acclimatization. 2) Are they wanting full scrimmage, is there a time requirement between contests? Has this recommendation ben run past Sports Medicine Committee? Should officials be hired, or ambulances? Are number of plays to be restricted? What about catastrophic insurance? Could we just do the pre-season scrimmage rule? Isn't this a regression? Do not see a full scrimmage game as a good thing. Wouldn't be a full out game, but limited scrimmage. The cost for nonschool is getting cost prohibited. School vs. school gives more control over the scrimmage. 40% in favor; 60% opposed. 3) 98% in favor of individual days, 2% in favor of grouped day. 4) Not really a strong feeling on difference between college and non-school hosts. 5) 100% want to keep full contact during the summer.

Mexico (Northeast District):

1) 100% in favor of heat acclimatization. 2) What is different than schools hosting and a third party? As a football coach, don't want to do it. Full contact - 100% opposed. Preseason scrimmage - 10% in favor, 90% opposed. 3) Al in favor of a day for a day. 4) Few in favor of more flexibility for colleges. 5) 20% in no contact, 30% in favor of contact.

Dexter (Southeast District):

What if there is an extended period of time between contact, should they redo the 5 day of acclimatization? 100% in favor of requiring.
No, we don't need full contact during the summer. The intent was not to have full contact games. 100% opposed to full contact games during the summer.
100% in favor of one for one.
100% no difference.
5% in favor, 9% opposed.

Area Meeting Report (cont'd)

3. All-Star Contests: Is deregulation desired by the membership? Blue Springs South (Kansas City District):

New group that didn't know how to fill the paperwork out which cost them the ability to allow kids to play. 40% in favor of deregulations.

Waynesville (South Central District):

Agree it is time to let them go. Do we keep it at two all-star games? 70% in favor of changing rule to deregulate; 30% opposed.

Cameron (Northwest District):

Meat markets pay your fee and get to play in all-star. Football different in the way they can put teams together. Evaluation events are different than All-Star Games. You haven't been based on. Parents don't see it or occur. 1) 100% change. 2) 50-50 on deregulation. Find out from NCAA on the number of allowed for eligibility.

McCluer South-Berkeley (St. Louis District):

Want the rule, and it protects the student. From a safety standpoint, need the rule. 10% change, 90% keep the rule.

Republic (Southwest District): 40% change, 60% remain the same.

Smith-Cotton - (Central District):

Is this for anyone? Is this out of season? Out of season is Ok. Deregulation would still allow the school to say no. What about someone inviting a state championship team? 80% in favor of deregulation.

Mexico (Northeast District):

All-Star Contest - let the parents make the decision: This is out of the season. What is the draw back? 100% in favor of deregulation.

Dexter (Southeast District):

Would it change the amount of All-Star events? Can we have our rule reflect the NCAA? 60% deregulate, 40% keep.

4. Seasons for the sports of Golf and Tennis

Blue Springs South (Kansas City District):

Is this a Title IX issue? Breakdown numbers by class (small vs. large). Can you just move the girls to advantage season? Could we end up moving others (Softball?) Ask about softball instead of golf or tennis. Q1) Swap golf - 40%, Tennis - 60%. Q2) Generally negative. Q3) Detrimental - golf 70%, Tennis - 30%.

Waynesville (South Central District):

Look to move golf at Waynesville because of swing sport. Same number of weeks? Are there more golf than tennis? Less impact move that. Q1) 70% Tennis switch.

Cameron (Northwest District):

Smaller school impacted more than larger school. Can girls golf only move to the spring with boys? Golf coach that coaches both would miss too much school if girls and boys season were at the same time. Should we push for a change in season until pushed on the issue? Rather switch tennis than golf - 70% - 30% - switch tennis.

McCluer South-Berkeley (St. Louis District): Switch golf - 1. Switch tennis - 5. No change - 90%.

Republic (Southwest District): Q1) Golf obvious choice.

Smith-Cotton - (Central District):

Less than half or about half have these two sports or one of them. Golf good switch. Could allow us to offer it. Baseball kids could play. Golf - Boys will conflict with football. Very few raised their hands for golf or tennis. Not all voted. Tennis would be better. Big school sport more opportunities. Golf would impact more.

Mexico (Northeast District):

Concerned about number of golf schools who play football. Boys golf may not exist if we move to fall. Rock Bridge believes tennis switch is easier from facilities standpoint. Tennis move - 70%, Golf move -30%.

Dexter (Southeast District):

1) Switch golf or tennis? Golf - 15 schools, tennis - 3 schools.

5.Start Date for Basketball and Wrestling - Practices & Contests Blue Springs South (Kansas City District):

Basketball: Season already too long. Not tough to move games from basketball. Do teams in traditional tournament get to start early? Schedule games during (post season). Would push back reduce season limits? Wrestling: Plus - weight management, facility available. SEC Swim and Dive conflict. Ok to reduce contest limits. Compressing the schedule would be fine. Already not wrestling till 1st week in December. Basketball: Opt. 1 - 1%, 2 - .5%, 3 98%. Wrestling: Opt. 1 - 0%, 2 - 0%, 3 - 1%, 4 - 80% (start practice one week later, state stays the same).

Waynesville (South Central District):

Season is too long. How did we come up with 50 yrs.? Like the ability to start but gives options. What's the hesitation to allow starting tournament? Can we move up the tournament date -Basketball? Can we make tournament play not before Wednesday - Basketball? Like where wrestling championships. Basketball - Opt. 1 - 3; 2 6; 3 - 3. Wrestling - Opt. 1 - 5; 2 - 2; 3 - 0. Tournament stay - 100%, move - 0.

Cameron (Northwest District):

Comments that in two years the schools will want to move fall season again so why change what we currently do. Why not say if you have a tournament currently over Thanksgiving you are grandfathered? Basketball- Opt. 1 - 95%; 2 - 5%, 3 - 0%. Wrestling - Opt. 1 - 25, 2-1, 3 - 0.

McCluer South-Berkeley (St. Louis District):

Basketball - Opt. 1 - 4-5, 2 - 3-4, 3 - 90%. Wrestling - Opt. 1 - 3-4, 2 - 50%, 3 - 50%.

Republic (Southwest District):

Basketball - Opt. 1 - 6-7, 2 - 2-3, 3 - 70%. Wrestling - Opt 1 - 0, 2 - 0, 3 - few, Shorten season-practice week later-same state dates - 70%.

Smith-Cotton - (Central District):

Impact on winter season. Change in number of contests? No. Basketball - Opt. 1 - No change desired - 6 or 7; 2 - 6 or 7, 3 - 20. Wrestling - Opt. 1 - 0; 2 - few, 3 - few, (Not listed 4) - most.

Mexico (Northeast District):

0% play in a tournament before Thanksgiving and Thanksgiving. Basketball: Opt. 1 - 20%, 2 - 5%, 3 - 75%. Wrestling: Opt. 1 - 0%, 2 - 2%, 3 - 20%. Option 3 with championships not moving - 70% shorten season one week.

Dexter (Southeast District):

40% play in Thanksgiving Tournament. Basketball: Opt. 1 - 10%, 2 - 10%, 3 - 1 school. Traditional tournament - 30+ years. Wrestling: Opt. 1 - 2 schools, 2 - 1-2 schools, 3 - 1-2 schools, 4) 5% (shorten season).

Area Meeting Report (cont'd)

6. Classifications ad hoc Committee

Blue Springs South (Kansas City District):

Where did 1.9 - 2.1 range come from? Class 1 basketball skewed. Bubble in middle classes - how handled. Use championship factor and multiplier together? Who moves down? Would allow voluntary play up. Can move up twice? (Championship factor). Individual sports: Based on entries. Adding Classes: Participation (general). Free/Reduced Lunch Factor? Special Education Factor? Like to knock off the big dog.

Waynesville (South Central District):

Schools are doing things that aren't correct. School discipline. Schools need to be called out. Question on Pembroke Hill and Vashon issues. Pembroke Hill - self-reported. Vashon - Self-reported and forfeited the trophies. Championship Factor - Not sure if works. Do we have a move down suck factor? Is that fluid number on the differential? What do we do with additional championships? Distance of district size. Is there a possibility of having girls and boys with different classifications? Would the breaks become even? Would boys success determine girls success? Would they be separate questions? Using the 2.0 Differential as the multiplier. What does dominance mean? How long are you up until you move down? How many states have success factor? How do administrators make things better - calling spade a spade.

Cameron (Northwest District):

Success Factor: All districts not created equal but you would have to absorb that success factor. Small school athlete turnover. Move private schools up one class. We have a good organization that leads us and at times we have to accept things that don't help our individual schools but we have to be very careful on what/how we treat charter/ private schools and not give a reason for government officials to have more interest in controlling us. 1) How many in favor of classifications breaks using differential of middle class schools enrollment - 95% yes, 5% no. 2) In favor of success factor: Yes - 0, No - 100%. If a district doesn't fill a weight class, bring the 5th place finish in from other districts to fill bracket. Individual - based entries: 90-10% not in favor. Team championships add sectionals - 100%.

McCluer South-Berkeley (St. Louis District):

#2) Consider wrestling similar to track scenario (pole vaulters in lower classes). #3 b - Death sentence for smaller football schools. #4 - Weary of using past success to determine class. Long term effect of 3-4- year run. #1 - Using 1.9-2.1 criteria - 85-90%. #2 - Using number of entries to set classes - Yes - 98%, No - 2%. #3 - Different sports impacted differently by multiplier. Smaller schools struggling - then move them up will kill programs. Using middle classes to determine multiplier. Multiplier - change 0%. Eliminate multiplier - 9-% - 100% of private schools. Public schools must accept all students. #4 - Would like - 30%, No - 40%

Republic (Southwest District):

1) - More classes waters down competition. Need for change? Why change? Support 1.9-2.1 ratio is positive (fluid). Classification by gender. 2) - support. 3) - Bump up non-public 1 class. Not in favor of multiplier and bump up combined. 4) - Punish schools for recent success - adverse impact on present/future kids 4 + years. Boys/girls - different classes at one school. Can school request to move up?

Smith-Cotton (Central District):

Team sports - thoughts/ideas. 2.1 ratio very reluctant to vote. Leave classification the same and increasing multiplier or moving privates up one class - very few. Individual sports - more would move down? Yes. Not much feedback. Talked some about cross country. Nonpublic - worry about legislature with changes with nonpublic schools. Cap? How much could they move up? Number being objective = positive. How do you set the championship factor? Taking money away - hosting - fans and concessions. Favor of using disparity factor as multiplier - most. Votes: Could you remove the outliers, top 5 and bottom 5? Maybe for biggest class but not class one. Would multiplier differ by sport? - yes. Up one class? - No. Championships Factor: Years 4 - 1, 6 - most, 8 - a few. Will affect boys/girls teams at one school differently. Public and private both - yes. How will it affect schools above you? If one goes up.One comes down. Review every year and change. Go down below your enrollment? -No you won't. How do points track? If you win in the upper class - what then?

Mexico (Northeast District):

Football Advisory Committee Meeting Held December 14, 2017

1. Recommend a change Bylaw 3.15.6a-3 to state Full-pad tackle football is only allowed after a period of five days of heat and equipment acclimatization, two days helmet only and three days helmet and shoulder pads only.

Amended: Recommend Bylaw 3.15.6a-3 to go to Area Meetings to discuss Full-pad tackle football during the summertime being permitted after a period of five days of heat and equipment acclimatization, two days helmet only and three days helmet and shoulder pads only.

2. Recommend a change to Bylaw 3.16.6b to state the preseason inter-school scrimmage shall consist of at least 3 schools.

3. Recommend with passage of change to Bylaw 3.16.6b, change MSHSAA Board Policy 28 to: Football

MSHSAA State Golf Championships: Coach/Fan/Spectator Guidelines - Use of Golf Carts

The use of golf carts by coaches/fans/spectators as part of the "gallery" at the MSHSAA State Golf Championships is restricted. The only exception to this restriction is the cases of coaches/fans/spectators with a medical condition, handicap or disability. In these cases, the following protocol must be followed in order to receive approval to use a golf cart as member of the "gallery" at the MSHSAA State Golf Championships.

- Fan/Spectator must communicate to the school administrator the need for a written request from the school administrator 1. on school letterhead indicating the necessity for permitting the use of a golf cart for the fan/spectator. The written request from the school administrator must provide (first/last) name of fan/spectator, reason for request (medical condition, handicap, disabled) and the state championship site they will be attending. The school administrator will provide the letter of request to the fan/spectator who will be required to bring the letter of request to the state championship manager at the site of the state championship being attended. The state tournament manager will then communicate with the club or club administrator the approval for the use of a golf cart for the named fan/spectator.
- School Coach must communicate to the school administrator the need for a written request to be submitted to MSHSAA 2. on school letterhead indicating the necessity for permitting the use of a golf cart by the coach during competition days at the state championships. The written request from the school administrator must provide (first/last) name of the coach, reason for request (medical condition, handicap, disabled), description of the change in the medical condition/disability from the regular season to the postseason and the state championship site they will be attending. The school administrator will submit the letter of request directly to the MSHSAA Office (Greg Stahl). An approval letter from MSHSAA will be considered and submitted back to the school administrator. The school coach will be required to bring the approval letter to the state championship manager at the site of the state championship being attended. The state tournament manager will then communicate with the club/club administrator the approval for the use of a golf cart for the named fan/spectator.

Note: Any rental fee for a golf cart is at the expense of the fan/spectator. Each course/site do not have the same amount of available golf carts for fan/spectator use; therefore, carts will be issued based on availability. The amount of the cart rental fee is under the jurisdiction of the host site course, not the MSHSAA.

ACT and SAT Dates Should be Checked to Avoid Conflicts with MSHSAA **Events**

High school counselors, principals, coaches and directors are urged to remind all high school students of the dates on which the ACT and SAT tests will be administered, as well as the dates of MSHSAA district and state events. MSHSAA event dates are contained in MSHSAA sport and activity manuals, the MSHSAA wall calendar and inside the back cover of the MSHSAA Handbook.

High school students participating in interscholastic activities often find conflicts between interscholastic events and the ACT and SAT test dates. Students can avoid this problem by arranging for a test date that does not conflict with an interscholastic event in which they will be participating.

Literature may be submitted anytime throughout the year; however, it will be kept on file until the next review cycle for that specific area.

Three Year Review Cycle

Vocal Literature - Summer of 2018 String Literature - Summer of 2019 Winds/Percussion/Piano Literature - Summer of 2020 Materials must arrive at MSHSAA on or before June 1st

New Music Submissions

To submit new literature for consideration to be placed on the MSHSAA PGML please follow the steps below. Please review the matrixes for each area of the list prior to submitting literature. Each matrix is located on the MSHSAA website under the Music Activities link.

Print and complete the specific 'Literature Addition Request Form' for each title you are submitting for consideration. Each form is located on the MSHSAA website. The forms have been specifically designed for each area of the list. Please be sure to select the appropriate request form for your selection(s).

Attach a photocopy (Do not send ORIGINALS) of the score with the 'Literature Addition Request Form' and mail to the MSHSAA Office on or before June 1st. For solos, include a copy of the soloist part with each measure numbered. For ensembles, all parts shall appear on the score and each measure should be numbered. Do NOT send originals! All photocopies will be destroyed after the review.

A completed 'Literature Addition Request Form' must accompany each title being submitted for review. Any music submitted without a completed 'Literature Addition Request Form' will not be reviewed and the music will be returned to the sender.

The individual school directors play a major role in the development and maintenance of the list. Please do not submit literature just because the music is in your library rather; submit quality literature that is not currently listed. Please consider sharing this information with studio or private music instructors as well. Be certain to submit your music before June 1st. Music received after June 1st will not be reviewed for consideration for the 2019 music festivals.

Music Submitted for Timing Considerations Only

If you have a selection that you feel has been timed incorrectly please submit the selection using the steps outlined below to the MSHSAA office for review. Please contact the MSHSAA office if you have additional questions. To submit literature currently appearing on the MSHSAA PGML for timing considerations only please use the steps below.

Print and complete a 'Timing Clarification' form located on the MSHSAA website for each selection submitted with timing concerns.

Attach a photocopy of the score (ensembles only) or soloist's part with the timing clarification form and mail to the MSHSAA office on or before June 1st. For solos and ensembles, please number each measure of the work. Do NOT send originals. All photocopies will be destroyed after the review.

A 'Timing Clarification' form must accompany each title being submitted for review.

Coach Defined

A coach is one who provides any type of instruction specific to a sport or activity. All coaches, paid or not paid, must be submitted online. Such person shall, therefore, meet the standards for coaching in the interscholastic program as provided in By-Laws 3.1 through 3.1.10. A coach must be "approved" by the MSHSAA office prior to instructing students. An egregious or intentional violation of the MSHSAA by-laws or the rules/regulations of the sport may cause the Board of Directors to withhold "approved" status.

Rules Review Requirement

Each school shall be responsible for requiring all coaches (as defined in By-Laws 3.1 through 3.1.10) to complete a MSHSAA Online Rules Review, except for those coaching an emerging sport. When a coach does not complete the online rules review within the time allowed, there will be a \$50 fine per coach to open the review.

Required Submittal of Adjudicators' Evaluations by Schools

Each school music director submitting entires to the MSHSAA Music Festivals shall submit the required adjudicators' evaluations via the Festival Manager website by the established deadline. Schools with solo and small ensemble events qualifying for the state music festival must be submitted **prior** to entering the state music festival. For large groups, state solo and small ensemble, and non-state events, the deadline is **May 15th**. This Board Policy is located on the MSHSAA website under the 'Music Activities' link. *A \$25.00 late penalty fee will be assessed to each school music director that fails to submit the required adjudicator evaluations(s) by the established deadlines.*

The adjudicator evaluations are intended to provide practical feedback to the adjudicator on his/her strengths as well as identifying areas to improve. This process also assists the district festival manager and MSHSAA office when securing adjudicators for future festivals. Keep in mind that you are providing useful feedback as to how the judge performed/executed his or her responsibilities as a MSHSAA adjudicator. Comments should be constructive in nature and not personal attacks on the individual; just as you would expect to see on your soloist and ensemble evaluation form(s).

Complete the evaluation(s) on time and avoid the fee!

How Do Students and Parents Learn the Eligibility Requirements?

An incoming seventh grader or ninth grader enters your school with anticipation of activity participation. It is her first opportunity to be a part of an interscholastic program. The student and the parents are unaware of academic requirements, semesters of participation, age requirements, nonschool competition requirements, amateur and awards standards, etc. How are our young people and their parents to learn of the eligibility requirements necessary to earn and maintain student eligibility? How do they learn about the interscholastic program, its purpose and philosophy? This is essential.

It is the responsibility of the staff of each member school to properly advise and educate the students and their parents of the eligibility requirements. The youngsters in our programs are placed in a vulnerable position when the school administration and activities staff do not review and clarify the eligibility rules and the purpose and philosophy of our programs.

Member schools should make certain that students expecting to compete in their school's athletic and activity programs clearly understand the standards of eligibility. As an aid in properly informing students, the MSHSAA annually publishes a brochure entitled "How to Protect Your High School Eligibility." A copy of this brochure is sent to all member schools in the August packet each year and with the sport rule book mailings. Member schools may make copies or order a supply from the MSHSAA office at a minimal cost per copy to cover the costs of printing and postage. The information can also be found at www.mshsaa.org.

All students participating in athletics and activities should be given one of these brochures as standard procedure. In addition, coaches and directors should take time to review the pamphlet with members of their sports squads and activities groups to explain all eligibility requirements. Eligibility requirements and school policies for participation should be provided in writing to all students and parents. The purpose and philosophy of the school program should be reviewed with all parties involved.

Posters on How to Protect Your Eligibility shall be distributed to all member schools in August. Please post these in prominent locations. Extra copies are available from the MSHSAA office.
